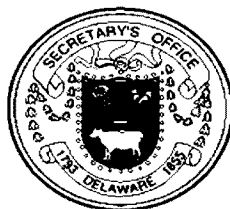

**CERTIFICATE OF AMENDMENT TO
ELEVENTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF TEMPUS LABS, INC.**

Tempus Labs, Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the “*General Corporation Law*”), does hereby certify:

ARTICLE I

The name of the corporation is Tempus Labs, Inc. (the “*Corporation*”).

ARTICLE II

The Corporation was originally incorporated pursuant to the General Corporation Law on September 21, 2015, under the name Bioin, Inc.

ARTICLE III

Pursuant to Sections 141 and 242 of the General Corporation Law, this Certificate of Amendment to the Eleventh Amended and Restated Certificate of Incorporation (the “*Certificate of Amendment*”) amends the Corporation’s Eleventh Amended and Restated Certificate of Incorporation (the “*Certificate of Incorporation*”) as follows:

Article FIRST of the Certificate of Incorporation is hereby amended and restated in its entirety to read as follows:

“**FIRST:** The name of this corporation is Tempus AI, Inc. (the “*Corporation*”).”

ARTICLE IV

This Certificate of Amendment has been duly adopted in accordance with Sections 141 and 242 of the General Corporation Law.

ARTICLE V

All other provisions of the Certificate of Incorporation, as currently on file with the Secretary of State of the State of Delaware, shall remain in full force and effect.
