RELEASE OF GRANT OF SECURITY INTEREST
IN UNITED STATES PATENTS

THIS RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES PATENTS, dated as of February 29, 2024, (this "Release") is made by JPMORGAN CHASE BANK, N.A. in its capacity as administrative agent (the "Administrative Agent") under the Confirmatory Grant of Security Interest in Patents (as amended, supplemented or modified and in effect from time to time, the "Patent Security Agreement"), between RHINO RACK AUSTRALIA PTY LTD, a company incorporated in Australia and registered in Victoria, (the "Grantor") and the Administrative Agent. Terms used but not defined herein have the meanings provided in the Patent Security Agreement.

WHEREAS, pursuant to the Patent Security Agreement which was recorded at the United States Patent and Trademark Office on September 14, 2021 at Reel 057499 Frame 0344, the Grantor granted to the Administrative Agent a continuing security interest in all of Grantor's right, title and interest in Patents, including those set forth on the attached Exhibit A.

WHEREAS, Grantor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Patent Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Patent Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Released Collateral, and (d) reassigns, grants and conveys to Grantor any and all right, title and interest it has in the Released Collateral.
