# NOTICE OF PARTIAL TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENT RIGHTS

This NOTICE OF PARTIAL TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENT RIGHTS (this "Partial Termination and Release"), effective as of March 11, 2024, is made by JPMORGAN CHASE BANK, N.A. ("JPMCB"), as Administrative Agent for the Secured Parties (in such capacity, the "Administrative Agent"), in favor of FMC TECHNOLOGIES, INC., a Delaware corporation (the "Grantor").

# WITNESSETH:

WHEREAS, pursuant to (a) the Credit Agreement dated as of February 16, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, including pursuant to that certain Fifth Amendment to the Credit Agreement dated as of April 24, 2023, the "Credit Agreement"), among TECHNIPFMC PLC, a public limited company incorporated under the laws of England and Wales (the "Company"), FMC TECHNOLOGIES, INC., a Delaware corporation (the "U.S. Borrower"), TECHNIPFMC FINANCE LIMITED, a private company limited by shares organized under the laws of England and Wales ("FinanceCo", and, together with the Company and the U.S. Borrower, the "Borrowers"), the Lenders and Issuing Banks from time to time party thereto and JPMCB, as Administrative Agent, (b) the Security Agreement dated as of February 16, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the U.S. Borrower, the Grantors from time to time party thereto and JPMCB, as Administrative Agent, and (c) that certain Patent Security Agreement, dated as of June 23, 2023 (the "Patent Security Agreement") between the Grantor, the other grantor party thereto and the Administrative Agent, as security for the payment or performance, as the case may be, in full of the Obligations, the Grantor, pursuant to the Security Agreement, granted to the Administrative Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest (the "Security Interest") in all of such Grantor's right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement), including the Patents listed on Schedule I thereto;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on July 3, 2023 at Reel/Frame No. 064193/0870;

WHEREAS, the Patent Collateral included, among other things, the Patents of the Grantor listed on <u>Schedule A</u> attached hereto (the "<u>Released Patent Collateral</u>");

WHEREAS, the Grantor has requested, and the Administrative Agent has agreed to provide this Partial Termination and Release in order to terminate and release its Security Interest solely in the Released Patent Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms of this Partial Termination and Release, the Administrative Agent hereby agrees as follows:

SECTION 1. <u>Terms</u>. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Credit Agreement, the Security Agreement or the

SECTION 2. Release of Security Interest in Released Patent Collateral. The Administrative Agent, without recourse, representation or warranty of any kind, hereby terminates, releases, discharges, and cancels all of its Security Interest in the Released Patent Collateral arising under the Patent Security Agreement and the Security Agreement, as applicable. If and to the extent the Administrative Agent has acquired any right, title or interest in the Released Patent Collateral under the Patent Security Agreement or the Security Agreement, as applicable, the Administrative Agent hereby re-transfers, re-conveys and reassigns such right, title or interest to the Grantor.

SECTION 3. <u>Partial Release</u>. This Partial Termination and Release is applicable only and solely with respect to the Released Patent Collateral and no other Patent Collateral arising under the Patent Security Agreement or the Security Agreement. Except as expressly modified hereby, the Patent Security Agreement and the Security Agreement shall remain in full force and effect, each in accordance with the provisions thereof on the date thereof.

SECTION 4. <u>Recordation</u>. The Administrative Agent hereby authorizes and requests that the Commissioner for Patents of the United States Patent and Trademark Office record this Partial Termination and Release.

SECTION 5. Governing Law. THIS PARTIAL TERMINATION AND RELEASE, AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS PARTIAL TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
