PATENT SECURITY AGREEMENT

This PATENT SECURITY AGREEMENT is entered into as of February 16, 2024 (this “**Agreement**”), among Wilson Sporting Goods Co. (the “**Grantor**”) and Wilmington Trust (London) Limited as collateral agent for the First Lien Notes Secured Parties (in such capacity, the “**Collateral Agent**”).

Reference is made to that certain Pledge and Security Agreement, dated as of February 16, 2024 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time and in effect on the date hereof, the “**Security Agreement**”), among the Grantors party thereto and the Collateral Agent, delivered in connection with that certain Indenture, dated as of February 16, 2024 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect on the date hereof, the “**Indenture**”), among Amer Sports Company, a Delaware corporation (the “**Issuer**”), the Note Guarantors party thereto, The Bank of New York Mellon, as Trustee, Registrar, Transfer Agent and Paying Agent (in such capacity, the “**Trustee**”) and the Collateral Agent. Consistent with the requirements set forth in Section 12.1 of the Indenture and Section 4.3(a) of the Security Agreement, the parties hereto agree as follows:

SECTION 1. **Terms.** Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement.

SECTION 2. **Grant of Security Interest.** As collateral security for the prompt and complete payment or performance in full when due, whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise of the Secured Obligations, the Grantor, pursuant to the Security Agreement, did and hereby does grant to the Collateral Agent, for the benefit of the First Lien Notes Secured Parties, a security interest in and continuing lien on all of such Grantor’s right, title and interest in, to and under the following, in each case whether now owned or hereafter acquired by such Grantor or in which such Grantor now has or hereafter acquires any right, title or interest and wherever the same may be located (collectively, the “**Patent Collateral**”):

A. all United States and foreign patents and certificates of invention, and applications for any of the foregoing, including, without limitation: (i) all patents and patent applications including, without limitation, the patents and patent applications listed in Schedule I hereto, (ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations thereof, (iii) all patentable inventions, designs and improvements claimed therein, (iv) the right to sue or otherwise recover for any past, present and future infringement or other violations thereof, (v) the right to receive all Proceeds therefrom, including, without limitation, license fees, royalties, income, payments, claims, damages and proceeds from suit, now or hereafter due and/or payable with respect thereto and (vi) all other rights of any kind accruing thereunder or pertaining thereto throughout the world;

in each case to the extent the foregoing items constitute Collateral.

Notwithstanding anything to the contrary herein, this Agreement shall not constitute a grant of a security interest in any Excluded Assets.

SECTION 3. **Security Agreement.** The security interests granted to the Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Security Agreement. The Grantor hereby acknowledges and affirms that the rights, protections and remedies of the Collateral Agent with respect to the Patent Collateral are more fully set forth in the Security Agreement, the terms (including, without limitation, Section 10) and provisions of

which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 4. ***Governing Law.*** This Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.


