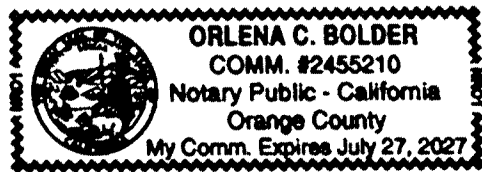

CLAUSES:



THIRD. - The assignment is understood to be exclusive and without any limitation, granting JIMMY VILLALVAZO the authority to exploit the invention to the exclusion of any other party, including the assignors themselves, and even to grant non-exclusive authorizations to third parties.

Furthermore, the assignment confers upon JIMMY VILLALVAZO the standing, independent of that of the assigning inventors, to pursue any infringements affecting all the powers inherent to their inventors as conferred in the Patent Law of Inventions and Utility Models IN MEXICO, THE UNITED STATES, CANADA, AND THE ENTIRE WORLD.

FOURTH. - As compensation for the authorship part corresponding to them, whose assignment is the subject of this contract, WILL BE GRATUITOUSLY, WITHOUT ANY LIMITATION, AND WITHOUT CLAIM FOR SUBSEQUENT AMOUNTS. LEAVING THE ASSIGNEE SAFE FROM ANY LITIGATION OR CHARGE RELATIVE TO THE PATENT.

FIFTH. - THE PARTIES, in accordance with the Law of Patents of Inventions and Utility Models IN MEXICO, THE UNITED STATES, CANADA, AND THE ENTIRE WORLD, are obliged to include the names of the inventors in both national and international patent applications, and to observe the administrative formalities required for the circulation and exploitation of the invention.

SIXTH. - This agreement shall have a duration of 20 years from this date, subject to the limitations contained in the Law of Patents of Inventions and Utility Models OF THE MENTIONED COUNTRIES AND THE ENTIRE WORLD.

SEVENTH. - This assignment agreement shall be governed by and interpreted in accordance with the Law of Patents of Inventions and Utility Models OF MEXICO and, in general, by the legal provisions applicable to it.

EIGHTH. The parties designate as their respective addresses for notifications, those stated at the beginning of this contract and commit to informing each other through written notification of any changes of address for the purpose of communication regarding any aspect of this contract.

NINTH. - This contract, as well as its execution, shall be governed by the laws of MEXICO and the international conventions and treaties in which MEXICO is a party.



ELEVENTH. - The parties agree on the following directive:

The parties agree that the Gross Margin currently allocated to Interlatin is 25% of the ongoing contract with Stentech.

50% of this sum shall be paid to Alejandro Carrillo.

Example:

The current average monthly amount due is 8,000 USD, this new agreement will be assigned at a 50% rate, through this agreement 4,000 USD will be paid to Alejandro Carrillo.

This applies only to sales in the market of Guadalajara, Jalisco.

TWELFTH.

The rest of the market is open to negotiations. Therefore, an option is offered to allow a change in the dividend location at a rate of 25% vs 50%.

This would apply to all Sales in the rest of the world.

And for the record, TWO copies of this document are signed for a single purpose, at the place and date indicated at the beginning.
