SECURITY INTEREST IN PATENTS

WHEREAS, the Pledgor has entered into a certain Second Lien Patent Security Agreement, dated April 2, 2019 (the "Patent Security Agreement") with Collateral Agent, notice of which was recorded on April 3, 2019 at the United States Patent and Trademark Office at Reel 048788, Frame 0655.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges the Security Interest in the Patent Collateral of the Pledgor, and assigns, transfers and conveys to Pledgor such Security Interest in such intellectual property.
