2. Hereby consents to the recordation of this Assignment of Patents by Assignee with the Commissioner of Patents in all jurisdictions in which such Patents exist. Assignee agrees to assume responsibility for recording fees and other costs associated with recording of the title to the Patents.
3. Authorizes and requests the Commissioner of Patents and Trademarks to issue the Patents to Assignee of the entire right, title, and interest in and to the same.
4. Will make available, at Assignee's request and at Assignee's expense, any inventor of any of the Patents, to the extent that the inventor is still an employee or under the control of Assignor, to testify in any interference, opposition or other legal proceeding, to sign all papers, to execute all continuations, continuations-in-part, divisions, renewals, reissues, reexaminations, and extensions thereof, and to make all rightful oaths and generally do everything possible to aid Assignee and its successors, assigns, and other legal representatives to obtain and enforce any and all patents issued or that may issue from the Patents and for which they are an inventor.
5. Will, at any time and upon request and at the expense of Assignee, execute and deliver or cause to be executed and delivered by any inventor still within its employ or under its control any and all papers that may be necessary or desirable

to perfect the title to the Patents on behalf of Assignee and its successors, assigns, and other legal representatives.

6. Will, at any time upon request, communicate to Assignee and its successors, assigns, and other legal representatives such facts relating to the inventions described in the Patents or the history of the Patents as may be needed and known to it.
7. Represents and warrants that it holds the entire right, title, and interest in and to the Patents, that it has the right to convey this entire right, title, and interest to Assignee, that Assignor has not and will not create or execute any agreement in conflict herewith and that, unless otherwise indicated on Schedule A, the Patents are and will remain in full force and effect for at least thirty days after the effective date of the Assignment.
