2. This IP Assignment shall be binding upon and shall inure to the benefit of the Company and HY-C and their respective successors and assigns.
3. The Company agrees to execute all papers and perform such other proper acts as HY-C may deem reasonably necessary to secure for HY-C or its designee the rights herein assigned.
4. This IP Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this IP Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Missouri, without giving effect to any choice or conflict of law provision or rule (whether of the State of Missouri or any other jurisdiction).
