2. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America, and any other applicable governmental authority, to issue or transfer all applicable applications and registrations for the Patents to Assignee, as assignee of Assignor’s entire right, title, and interest therein. Assignee shall have the right to record this Confirmatory Assignment Agreement with all applicable government authorities so as to perfect its ownership of the Patents.
3. This Confirmatory Assignment Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original
