**FIFTH:** The merger is to become effective at 11:59 p.m. on September 30, 2016.

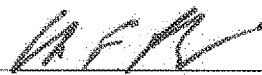
**SIXTH:** The Agreement of Merger is on file at 345 East Main Street, Warsaw, Indiana 46580, the place of business of the surviving corporation.
