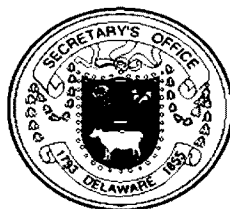

PerkinElmer Health Sciences, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify as follows:

This Certificate of Amendment amends the Corporation's Certificate of Incorporation, as amended (the "Certificate"), and was duly adopted by the Corporation's Board of Directors in accordance with the provisions of Sections 141(f) and 242 of the General Corporation Law of the State of Delaware, and was approved by written consent of the sole stockholder of the Corporation given in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
