ASSIGNMENT AGREEMENT OF PATENTS

(hereinafter referred to as the "Assignee")
on the other part

The Assignor and the Assignee will hereinafter be referred to as the "Parties".

WHEREAS

The Assignor is the owner of the Intellectual Property Rights (hereinafter referred to as the "IP Rights") described in the enclosed Exhibit (hereinafter referred to as the "Exhibit").

THE PARTIES HEREBY AGREE AND UNDERTAKE AS FOLLOWS

Art. 1) The Assignor hereby assigns to the Assignee the full, entire, and absolute property of the IP Rights together with the goodwill of the business, without any restriction and with all the rights and obligations deriving therefrom.

Art. 2) The Assignee accepts and purchases the full, entire, and absolute property of the IP Rights without any restriction.

Art. 3) The IP rights are assigned for a fair sale consideration agreed between the Parties.

Art. 4) All the costs for this Assignment and for recording it before the USPTO will be and will remain at the charge of the Assignee.




