### Certification

On the basis of today's inspection of the Commercial Register of Continental Teves AG & Co. OHG (cancelled company) at the Local Court of Frankfurt am Main under HRA 27047 by electronic means, I, Notary Dr. Florian Hartl, Hanover, certify that:

- a) Continental Automotive Technologies GmbH, Hanover (Hanover Local Court HRB 3669) has entered into the Company as General Partner (entered in the Commercial Register on June 29, 2022)
- b) Continental Aktiengesellschaft, Hanover (Hanover Local Court HRB 3527) has withdrawn from the Company as general partner, and Continental Automotive GmbH, Hanover (Hanover Local Court HRB 59424) has joined the Company as general partner (entered in the Commercial Register on July 1, 2022)
- c) Continental Automotive GmbH, Hanover (Hanover Local Court HRB 59424) has withdrawn from the Company as General Partner, the Company is dissolved, and the Company (Continental Teves AG & Co. OHG) has ceased to exist. (entered in the Commercial Register on July 14, 2022).

Continental Teves AG & Co. OHG has ceased to exist without liquidation. The legal basis is as follows:

Continental Automotive GmbH transferred its share to the co-shareholder Continental Automotive Technologies GmbH and thus Continental Automotive Technologies GmbH was the sole shareholder of Continental Teves AG & Co. OHG.

This transfer of shares is based on the spin-off of assets of Continental Automotive GmbH for absorption by Continental Automotive Technologies GmbH pursuant to the notarization dated June 3, 2022 - my UVZ 280/2022. The execution of the spin-off directly led to accretion pursuant to Sec. 738 para. 1 sentence 1 BGB in conjunction with Sec. § Section 105 para. 1, para. 3 HGB of Continental Teves AG & Co. OHG to Continental Automotive Technologies GmbH.

Continental Automotive Technologies GmbH is thus the universal successor (outside the law of conversion) of Continental Teves AG & Co. OHG, namely by accrual of all assets and liabilities of Continental Teves AG & Co. OHG to the assets of Continental Automotive Technologies GmbH.
