THIS SUPPLEMENTAL DEED OF ASSIGNMENT is made the
28th day of March Two Thousand and Twenty-Four

BETWEEN

- (1) **BOOGINHEAD LLC**, a Washington limited liability company having a place of business at 165 Front Street North, Issaquah Washington 98027, United States of America (hereinafter called "**the Assignor**") of the one part;

AND

- (2) **BLUE BOX TOY FACTORY LIMITED**, a Hong Kong limited liability company having a place of business at Room 1203, East Ocean Centre, 98 Granville Road, Tsim Sha Tsui East, Kowloon, Hong Kong (hereinafter called "**the Assignee**") of the other part

WHEREAS : -

1. By an assignment among the Assignor, the Assignee, Blue Box Imagination Limited and Blue Box OPCO, LLC dated 2 January 2024 ("**the Assignment**"), the Assignor has agreed to assign, convey and transfer all of its right, title and interest in, various intellectual property assets set out in Schedules 1 to 3 therein attached to the Assignee, Blue Box Imagination Limited and Blue Box OPCO, LLC respectively.
2. It has since transpired that one item of intellectual property asset that was meant to be assigned to the Assignee was not included in the list of General Non-Booginhead IP listed under Schedule 1 attached to the Assignment.
3. For the sake of completeness, the parties have agreed to execute this Supplemental Deed of Assignment to give effect to the assignment of the rights, title, interests and

benefit in the missing item which is listed under Schedule 4 attached hereto from the Assignor to the Assignee.

4. The Assignor has further agreed to assign unto the Assignee certain unregistered intellectual property rights together with the goodwill (if any) attached thereto subject to the rights and obligations set forth in this Supplemental Deed of Assignment.

NOW THIS ASSIGNMENT WITNESSETH THAT

1. In consideration of the sum of UNITED STATES DOLLARS TEN ONLY (US\$10.00) receipt of which is hereby acknowledged, the Assignor hereby assigns to the Assignee absolutely the following (collectively referred to hereafter as **"the IP Assets"**):-

- 1.1 all of the Assignor's unregistered trade marks and names of products currently in use in the Assignor's business worldwide as at the date of this Assignment, together with that part of the Assignor's goodwill as attached to such unregistered trade marks more particularly set out in Schedule 5;

- 1.2 all its property, rights, title, interests and benefit throughout the world (including all common law rights, causes of actions and the right to recover for past infringement) in, to, and under the improvements, the design patent as set out in Schedule 4, and all divisions, continuations, reissues, reexaminations, renewals, and extensions thereof, and all rights of priority under International Conventions and applications for Letters Patent that may hereafter be filed for said improvements or for the said design patent in the United States; and

- 1.3 all other intellectual property rights, including but not limited to (a) the copyright as subsisting in the works in relation to the creation of the subject matter and (b) the unregistered designs of the subject matter; together with all common

law rights, causes of actions and the right to recover for past infringement thereof.

For the purpose of this clause, "subject matter" means the subject matter being made the subject of the products as designed, produced, manufactured or sold by the Assignor in its business as set out in Schedule 5 attached hereto.

2. The Assignor warrants in favour of the Assignee that the Assignor has not assigned, licensed, granted, charged or in any way encumbered such rights assigned under this Assignment or done or omitted to do anything whereby its title may be impugned or encumbered.
3. The Assignee shall have the right to claim to be the proprietor of such unregistered trade marks, copyright or unregistered designs as are currently in use in the Assignor's business.
4. The Assignor covenants that it will execute all documents, papers, forms, authorizations and powers, and depose to or swear all declarations or oaths, which may be necessary or required by any government offices in any country with the purpose of further assuring, securing, completing or absolutely vesting full right, title and interest in and to the IP Assets and all the other unregistered rights in favour of the Assignee with the objective of giving full effect to the intentions of the parties hereto as herein provided.
5. The Assignor will so far as possible or permissible lend its name to and/or join the Assignee in any proceedings for infringement or passing off which the Assignee may require to be brought against any person infringing the Assignor's rights to any of the IP Assets; and the Assignee holding harmless the Assignor in respect of any costs or other liability arising out of such proceedings.

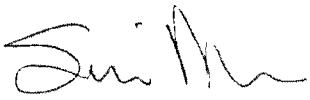

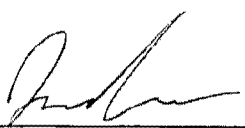

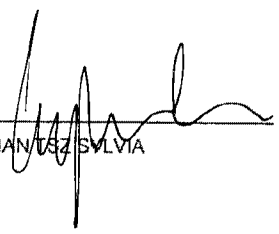
