**Release of Second Lien Security Interest in Patents**

This Release of Second Lien Security Interest in Patents, dated as of April 30, 2024 (the “Release”), is made by U.S. Bank Trust Company, National Association as successor to U.S. Bank National Association, as the collateral agent for the Secured Parties (in such capacity, the “Agent”) in favor of Press Ganey Associates, Inc., an Indiana corporation (the “Grantor”).

WHEREAS, by (i) that certain Second Lien Security Agreement, dated as of July 25, 2019 in favor of Agent (as supplemented by that certain Second Lien Security Agreement Supplement, dated as of February 5, 2021, Second Lien Security Agreement Supplement, dated as of August 23, 2021, Second Lien Security Agreement Supplement, dated as of April 21, 2023 and as further amended, restated, supplemented or modified from time to time, the “Security Agreement”) and (ii) that certain related Second Lien Patent Security Agreement, dated as of July 25, 2019 in favor of Agent (as amended, restated, supplemented or modified from time to time, the “Patent Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Patent Security Agreement, as applicable), which Patent Security Agreement was recorded with the United States Patent and Trademark Office on July 25, 2019 at Reel 049869 Frame 0266, the Grantor granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor’s right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement), including those Patents listed on Schedule I hereto;

WHEREAS, the Grantor desires Agent to release, discharge, terminate and cancel its lien on and security interest in the Patent Collateral of the Grantor, including, without limitation, the Patents set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties and without representation, warranty or recourse, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Patent Collateral of the Grantor and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Patent Collateral.

The Agent authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
