TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS

This Termination and Release of Intellectual Property Security Agreement (this “*Termination*”), dated as of May 3, 2024, is executed by **SILICON VALLEY BANK**, a division of **FIRST-CITIZENS BANK & TRUST COMPANY** (a successor by purchase to the Federal Deposit Insurance Corporation as Receiver for Silicon Valley Bank, N.A. (as successor to Silicon Valley Bank)) (“*Bank*”), in favor of **SKYTAP, INC.**, a Delaware corporation (“*Grantor*”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to (i) that certain Intellectual Property Security Agreement, entered into as of May 8, 2020 (as amended or supplemented, the “*Security Agreement*”) executed by the Grantor in favor of Bank, Grantor granted to Bank a security interest in its copyrights, patents and trademarks, including without limitation, the Intellectual Property Collateral (as defined below) and (ii) that certain Amended and Restated Intellectual Property Security Agreement, entered into as of August 21, 2023 (the “*Restated Security Agreement*” and together with the Security Agreement, the “*Security Agreements*”) executed by the Grantor in favor of Bank, Grantor granted to Bank a security interest in its copyrights, patents and trademarks, including without limitation, its copyrights described on Exhibit A, its trademarks described on Exhibit B and its patents described on Exhibit C (collectively, the “*Intellectual Property Collateral*”).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on May 11, 2020 at Reel 6936 and Frame 0097 and December 16, 2022 at Reel 7923 and Frame 0290, and with the Patent Division of the United States Patent and Trademark Office on May 11, 2020 at Reel 052628 and Frame 0264 and December 16, 2022 at Reel 062128 and Frame 0546, in each case, to evidence the security interest granted under the Security Agreement.

C. The Restated Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on August 23, 2023 at Reel 008175 and Frame 0530, and with the Patent Division of the United States Patent and Trademark Office on August 23, 2023 at Reel 064671 and Frame 0054, in each case, to evidence the security interest granted under the Restated Security Agreement.

Grantor has no outstanding obligations to Bank under the terms of the Security Agreements, and Bank agrees to release its security interest in the Intellectual Property Collateral.

AGREEMENT

Now therefore, Bank agrees that it terminates and releases its security interest in all of Grantor’s right, title and interest in, to and under Grantor’s Intellectual Property Collateral and reassigns to Grantor, without warranty or recourse, all interest of Bank in the Intellectual Property Collateral.
