may be granted therefrom, all reexaminations, and all reissues or extensions of such patents; said U.S. nonprovisional or foreign applications to be filed and issued in the name of ASSIGNEE or its designee insofar as permitted by applicable law;

AND, for the consideration aforesaid, ASSIGNOR does hereby agree, or to the extent already done so then confirms their agreement, that it or its executor(s) and legal representatives will make, execute and deliver any and all other instruments in writing including any and all further application papers, affidavits, assignments and other documents, and will communicate to said ASSIGNEE, its successors and representatives all facts known to ASSIGNOR relating to said inventions and improvements and the history thereof and will testify in all legal proceedings and generally do all things which may be necessary or desirable more effectually to secure to and vest in said ASSIGNEE, its successors or assigns the entire right, title, and interest in and to the said improvements, inventions, know how, applications, Letters Patents, rights, titles, benefits, privileges and advantages hereby assigned and conveyed, or intended so to be.
