INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION


WHEREAS, **LOOKINGGLASS CYBER SOLUTIONS, LLC**, a Delaware limited liability company (and successor in interest to Lookingglass Cyber Solutions, Inc., a Delaware corporation), previously located at 10740 Parkridge Blvd., Suite 200, Reston, VA 20191 and currently located at 1834 S. Charles Street Baltimore, MD 21230 (the "Grantor"), and Stifel Bank, a Missouri state chartered bank, located at 501 North Broadway, St. Louis, MI 63102 and/or 787 Seventh Avenue, 11th Floor, New York, New York (the "Secured Party"), entered into a certain Intellectual Property Security Agreement, dated as of May 31, 2023 (the "Agreement"), which was recorded in the United States Patent and Trademark Office on June 1, 2023 at Reel 8089 and Frame 0542 for trademarks and at Reel 063829 and Frame 0248 for patents and that by its terms granted Secured Party a security interest in certain intellectual property including intellectual property listed in Exhibits A, B, and C to this agreement; and

WHEREAS, the Grantor has caused to be paid and satisfied in full the obligations for which the security interest in the Agreement was granted.

NOW THEREFORE the Secured Party hereby releases all security interests granted in the Agreement, including but not limited to all right, title, and interest in, to, and under Grantor's intellectual property collateral, including but not limited to all proceeds thereof, the right to sue for past, present, and future infringements, all rights corresponding thereto throughout the world, and all re-issues, divisions, continuations, renewals, extensions, and continuations-in-part thereof, and in Exhibits A, B and C attached hereto. The Secured Party further agrees, for itself, its successors and assigns, to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Grantor, to effectuate this termination.

IN WITNESS WHEREOF the Secured Party hereto by the signature below of its duly authorized representatives agrees to be bound by the provisions of this Intellectual Property Security Agreement Termination as of the date of execution, this 13th day of May, 2024.
