RELEASE OF SECURITY INTEREST

This Release of Security Interest ("Release") is made as of May 16, 2024, by TriplePoint Capital LLC as collateral agent and lender ("Lender") in favor of Metropolis Technologies, Inc., a Delaware corporation ("Metropolis Technologies"), Metropolis Tennessee, LLC, a Tennessee limited liability company ("Metropolis Tennessee") and Metropolis Washington, LLC, a Tennessee limited liability company ("Metropolis Washington", together with Metropolis Technologies and Metropolis Tennessee, collectively the "Companies", and each, a "Company"). Capitalized terms not defined herein have the meanings set forth in the Security Agreements, as applicable.

RECITAL

WHEREAS, the Companies granted to Lender under (i) that certain Plain English Intellectual Property Security Agreement dated as of March 3, 2023 ("March 2023 Security Agreement"), which was recorded at the United States Patent and Trademark Office ("USPTO") on January 8, 2024 at Reel/Frame 8311/0349 and (ii) that certain Plain English Intellectual Property Security Agreement dated as of December 30, 2023, which was recorded at the USPTO on January 8, 2024 at Reel/Frame 066055/0934 ("December 2023 Security Agreement", together with the March 2023 Security Agreement, collectively the "Security Agreements"), a security interest in Intellectual Property Collateral, including the copyrights, patents and trademarks of the Companies set forth on the attached Exhibit A.

WHEREAS, the Companies have no outstanding obligations to Lender under the terms of the Security Agreements and Lender agrees to release its security interest in the Intellectual Property Collateral.


AGREEMENT

Now therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates the Security Agreements and terminates and releases its security interest in the Intellectual Property Collateral and reassigns to the Companies, without warranty or recourse, all interest of Lender in the Intellectual Property Collateral. Lender hereby authorizes the Companies and their respective successors, assigns or other legal representatives to file this Release with the USPTO, at the sole expense of the Companies, to evidence and effectuate the release and termination of Lender's security interest in the Intellectual Property Collateral.
