RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTERESTS IN PATENTS (this “Release”) is made as of April 30, 2024 (“Effective Date”), by REGIONS BANK, in its capacity as administrative agent and collateral agent for the Lenders and the LC Issuer (in such capacity, the “Administrative Agent”) in favor of BIAMP SYSTEMS LLC, a Delaware limited liability company (f/k/a BIAMP SYSTEMS CORPORATION, a Delaware corporation) (the “Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit Agreement (as defined below).

WITNESSETH:

WHEREAS, reference is made to that certain Credit and Security Agreement, dated as of November 30, 2017, as amended by that certain First Amendment to Credit and Security Agreement dated as of February 20, 2018, that certain Second Amendment to Credit and Security Agreement dated as of December 19, 2018, that certain Third Amendment to Credit and Security Agreement dated as of July 10, 2019, that certain Fourth Amendment to Credit and Security Agreement dated as of March 10, 2020, that certain Fifth Amendment to Credit and Security Agreement dated as of April 21, 2020, that certain Sixth Amendment to Credit and Security Agreement dated as of June 15, 2021, that certain Seventh Amendment to Credit and Security Agreement dated as of June 10, 2022, that certain Eighth Amendment to Credit and Security Agreement dated as of July 31, 2023 and that certain Ninth Amendment to Credit and Security Agreement dated as of February 23, 2024 (as so amended and as the same may be further amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), by and among Grantor, Biamp, LLC, a Delaware limited liability company (the “Borrower”), the other Credit Parties party thereto, the Lenders from time to time party thereto, and the Administrative Agent.

WHEREAS, pursuant to the Credit Agreement and that certain Notice of Grant of Security Interest in Patents, dated as of November 30, 2017 in favor of the Administrative Agent and recorded with the United States Trademark and Patent Office (the “USPTO”) on November 30, 2017 at Reel 044559, Frame 0731 (the “Patent Security Agreement”), Grantor granted to the Administrative Agent a security interest in those certain patents set forth on Schedule 1 hereto (the “Patent Collateral”); and

WHEREAS, the Grantor has requested a release of the security interest granted and recorded against the Patent Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) releases, terminates, discharges and cancels and re-assigns to the Grantor any and all liens, security interests, right, title and interest the Administrative Agent may have in, to and under the Patent Collateral, together with all proceeds thereof; (ii) agrees that it shall, at the sole cost and expense of the Grantor, execute all other documents and do all other acts reasonably requested by the Grantor to relinquish and effect the release of such rights to the Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and


any other filings necessary to evidence the release and termination of the Administrative Agent's rights under the Credit Agreement with respect to the Patent Collateral.

THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
