DEED OF ASSIGNMENT

This Deed of Assignment (hereinafter referred to "the Deed") is made on this ^{7th} day of May, 2024 (hereinafter referred to as the "Effective Date")

BETWEEN

ComboCap Inc. incorporated and existing under the laws of the United States of America, of the address: **125 Algonquin Parkway, Whippany, NJ- 07981, United States of America (US)** (hereinafter referred to as "the Assignor"), collectively on the one part;

AND

Vantage Nutrition LLC, incorporated and existing under the laws of the United States of America, of the address: **4 Hillman Dr #190, Chadds Ford, PA 19317, United States of America (US)** (hereinafter referred to as "the Assignee"), collectively on the other part.

WHEREAS:

- I. The Assignor is the Patentee/Applicant of the Patent/Patent Applications (hereinafter referred to as the "Assigned Patents") listed and identified in Exhibit A hereto;
- II. The Assignor has the right to assign the Assigned Patents as defined below and the Assignee desires to acquire an ownership interest in the Assigned Patents subject to the terms and conditions mentioned in this Deed;

NOW, THEREFORE, in consideration of the Deed and the mutual covenants and promises contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment – That for a consideration of USD \$ 1, Assignor hereby irrevocably convey, transfer, assign and deliver to Assignee, its successors and assigns, Assignors' entire right, title and interest for the United States Patents and Patent applications, its territories and possession, and all foreign countries (as marked in Exhibit A) in and to the Assigned Patents and all rights, claims and privileges pertaining thereto, including without limitation, all inventions and discoveries disclosed therein, certificates of invention and applications for certificates of invention, and any substitutions, reissues, reexaminations, divisions, renewals, extensions, provisionals, continuations, continuations-in-part, continued prosecution applications, and corresponding foreign patents and patent applications and foreign counterparts thereof, and any and all rights to sue and recover for claims and remedies against and collect damages and other recoveries for past, present and future infringements of any or all of the foregoing, and rights for priority and protection of interests therein under the laws of any jurisdiction and hereby grants to Assignee the right to apply, obtain and hold in its own name for patents or inventor's certificates and related rights heretofore or hereafter filed in any and all countries, including, without limitation, the right to prosecute and maintain the same and all rights to claim priority based thereon, all patents granted thereon and all reissues, extensions and renewals thereof.
2. Assignee shall be solely responsible for all actions and all costs whatsoever, including attorney's fees, arising after the Effective Date and associated with the perfection of rights, title, and interest in and to the Assigned Patents, and furthermore, upon Assignee's written request, Assignor shall execute all documents and instruments, and shall do all lawful acts, in each case as may be reasonably necessary and at Assignee's expense, to perfect Assignee's rights, title, and interest in and to the Assigned Patents. For documents that require notarization, the foregoing obligation of Assignor shall be satisfied if Assignor reasonably cooperates in obtaining signatures, notarized by an appropriate notary; any notarial authentication, legalization, and the like of such notarized signatures shall be obtained by Assignee at Assignee's expense.






3. Assignee's representatives shall be responsible for preparing and translating any documents that Assignee records to perfect its right, title and interest in Assigned Patents in any jurisdiction as mentioned in Exhibit A. Not later than ninety (90) days after the Effective Date, Assignee shall provide Assignor with any documents requiring Assignor's signature suitable for recording, having terms and conditions acceptable to Assignor and for any additional or different terms and conditions as may commonly exist or would be necessitated by law in patent assignments between Assignor and other entities organized under the laws of the local jurisdiction, if any. Assignee shall further provide Assignor with an English translation of each such document concurrently therewith.
4. Assignee shall be solely responsible for all actions and all costs whatsoever, including attorney's fees, arising after the Effective Date and associated with the continuous prosecution and the maintenance and enforcement of the Assigned Patents, and Assignor shall have no obligation to pay any maintenance fees which become due for the Assigned Patents after the Effective Date.
5. No license, immunity, ownership interest, or other right is granted under this Deed, now or hereafter, either directly or by implication, estoppel, or otherwise, except with respect to the Assigned Patents as expressly set forth herein.
6. Rights and Privileges – All rights and privileges, including the right to sue for and receive all damages from past infringements of the Assigned Patents, will be held and enjoyed by the Assignee and its successors, assigns and other legal representatives.
7. Further Assurances – Assignor represents and warrants to Assignee, its successors and assigns that on the Effective date hereof they are the exclusive owners of all right, title and interest in and to the Assigned Patents and have the right to assign the Assigned Patents, and that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment. Assignor agrees, at the Assignee's expense and request:
 - (i) to assign, deliver and communicate to Assignee, its representatives, agents, successors and assigns any facts and materials relating to the Assigned Patents, including evidence for interference purposes or for other legal proceedings whenever requested and all files, documents and communications pertaining to the Assigned Patents and Patent Applications, including all communications to and from Intellectual Property Offices / Patent Offices such as U.S. Patent and Trademark Office, EPO, etc., and any and all legal counsel advising on or assisting with the Assigned Patents and Patent Applications;
 - (ii) to testify in any interference or other legal proceedings whenever requested;
 - (iii) to execute and deliver whenever requested all lawful papers required to make any of the foregoing provisions effective; and
 - (iv) to generally provide all further cooperation, including taking such further action and executing such additional documents, which Assignee, its successors and assigns requests to secure, obtain or enforce proper protection for the Assigned Patents and all associated rights in this or any foreign country.
8. Authorization – Assignors authorize and request the Commissioner of Patents and Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership in patent registrations and applications for registration of patents, to record Assignee as the assignee and owner of any and all right in the Assigned Patents.
9. Miscellaneous – This Assignment will be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns, each of which such

successors and permitted assigns will be deemed to be a party hereto for all purposes hereof. This Assignment and any of the terms contained herein may be amended or modified by Assignors and Assignee only in writing. This Assignment is executed by, and shall be binding upon, Assignors and Assignee and their respective successors and assigns, for the uses and purposes set forth and referred to above, from the Effective Date.

10. Governing law and jurisdiction – The Parties accept the laws of the Delaware as the governing law of the Deed and submit to the exclusive jurisdiction of the Courts of Delaware.
