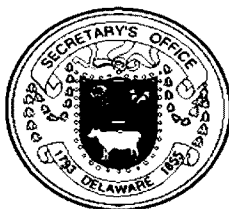


3. The Corporation’s Certificate of Incorporation is hereby amended by amending and restating Article “FIRST” in its entirety to read as follows:
