Intellectual Property Assignment Agreement

This Agreement is dated 31 August 2023

Between

- (A) **J. & P. Coats, Limited**, a company incorporated under the laws of Scotland, United Kingdom, with registered number SC002042, whose registered office is at 1 George Square, Glasgow, G2 1AL, United Kingdom;
- (B) **Coats Industrial Thread Brands Limited**, a company incorporated under the laws of England and Wales, with registered number 02896429, whose registered office is at The Pavilions, Bridgwater Road, Bristol, United Kingdom, BS13 8FD;
- (C) **Coats GmbH**, a company incorporated under the laws of Germany, with registered number HRB 270832, whose registered office is at 1 Suedwieke 180, 26817 Rhaderfehn, Germany (Coats GmbH, together with J. & P. Coats, Limited and Coats Industrial Thread Brands Limited, "**Assignors**"); and
- (D) **AEQH19 GmbH**, a company incorporated under the laws of Germany, with registered seat in Munich, Germany, registered with the commercial register of the local court of Munich under number HRB 280575, whose registered office is at Gabrielenstraße 9, 80636 Munich, Germany ("**Assignee**"),

each a "**party**" and together the "**parties**".

Recitals

- A. The Assignors together own all the Assigned IP Rights (defined below).
- B. Each of the Assignors has agreed to assign all its rights in the Assigned IP Rights (as applicable) to the Assignee, pursuant to the SPA (defined below) and in accordance with the terms and conditions of this Agreement.

It is agreed as follows:

1. Definitions and Interpretation

1.1 Definitions

In this Agreement the following words and expressions have the following meanings:

"**Assigned IP Rights**" means:

- (a) the Assigned Trade Marks; and
- (b) the Assigned Patents;

"**Assigned Patents**" means the patents set out in Schedule 1;

"**Assigned Trade Marks**" means the trade mark registrations and applications set out in Schedule 2;

"**Business Day**" has the meaning given to it in the SPA;

"**Completion Date**" has the meaning given to it in the SPA;

"**SPA**" means the Share Purchase Agreement entered into between Coats Industrial Thread Holdings B.V. (as the seller) and the Assignee (as the purchaser) dated 30 June 2023; and

"Transaction Documents" has the meaning given to it in the SPA.

1.2 Interpretation

In this Agreement (except where the context otherwise requires):

- (a) clause headings are inserted for ease of reference only and shall not affect construction;
- (b) any reference to a recital, clause or schedule is to the relevant recital, clause or schedule to this Agreement and any reference to a paragraph is to the relevant paragraph in which it appears; and
- (c) any reference to "include" or "including" (or any similar term) is not to be construed as implying any limitation and general words introduced by the word "other" (or any similar term) shall not be given a restrictive meaning by reason of the fact that they are preceded by words indicating a particular class of acts, matters or things.

2. Assignment

- 2.1 Pursuant to and in consideration of the good and valuable consideration paid under the SPA with respect to the Assigned IP Rights (the receipt and sufficiency of which is hereby acknowledged by the Assignors), each of the Assignors hereby assigns to the Assignee and with effect from the Completion Date, all of its right, title and interest in and to the Assigned IP Rights (as applicable), together with the right to sue in respect of every act of infringement of the Assigned IP Rights whether occurring before or after the Completion Date.

3. Further Assurance

- 3.1 For a period of five years commencing on the Completion Date, each of the parties agrees to use all reasonable endeavours to perform (or use all reasonable endeavours to procure the performance of) all further acts and things, and execute and deliver (or use all reasonable endeavours to procure the execution and delivery of) such further documents, as the others may reasonably require, to implement and/or give effect to this Agreement and the transactions contemplated by this Agreement.
- 3.2 The Assignee shall, at its own cost, make all relevant notifications, filings and/or submissions with the applicable intellectual property offices or registries to record the assignment of the Assigned IP Rights under this Agreement. If requested by the Assignee in writing, the relevant Assignor will provide reasonable assistance to the Assignee in relation to such recordal of assignment in accordance with clause 3.1.

4. Entire Agreement

- 4.1 This Agreement, together with the other Transaction Documents, represent the whole and only agreement between the parties in relation to the subject matter herein and supersede any previous agreement (whether written or oral) between all or any of the parties in relation to the subject matter of any such document save that nothing in this Agreement shall exclude any liability for, or remedy in respect of, fraud or fraudulent misrepresentation.
- 4.2 Each of the parties acknowledges and agrees that the only remedy available to it in respect of a breach of any provision of this Agreement shall be for damages for breach of contract and that no party shall have a claim or remedy in tort in respect of such breach. The parties further acknowledge and agree that they shall have no right to rescind this Agreement.

5. Governing Law and Jurisdiction

- 5.1 The construction, validity and performance of this Agreement and all non-contractual obligations arising from or connected with this Agreement shall be governed by the laws of England and Wales.
- 5.2 Any dispute or claim arising out of or in connection with this Agreement, including any question regarding its existence, validity or termination, shall be referred to and finally resolved by arbitration administered by the London Court of International Arbitration in accordance with the Arbitration Rules of LCIA (the "**Rules**"), which Rules are deemed to be incorporated by reference into this clause:
- (a) This clause 5.2 shall be governed by the laws of England and Wales.
 - (b) The number of arbitrators will be one.
 - (c) The seat, or legal place, of arbitration will be London, England.
 - (d) The language to be used in the arbitral proceedings shall be English.
 - (e) Service of any request for arbitration pursuant to this clause 5.2 must be made in accordance with the Notice provisions in clause 6 below.

6. Notices

- 6.1 Any notice, demand or other communication ("**Notice**") to be given by any party under, or in connection with, this Agreement shall be in writing (which shall include email) by sending it by email to the email address set out in clause 6.2, delivering it by hand or by courier by an internationally recognised courier company to the address set out in clause 6.2, in each case marked for the attention of the relevant party set out in clause 6.2 (or as otherwise notified from time to time in accordance with the provisions of this clause 6). Any Notice so served by email or hand shall be deemed to have been duly given or made as follows:
- (a) if sent by email, at the time of transmission by the sender (as recorded on the device from which the sender sent the e-mail);
 - (b) if sent by courier, 2 Business Days after posting; or
 - (c) in the case of delivery by hand, when delivered;

provided that in each case where delivery by email or by hand occurs after 6pm on a Business Day or on a day which is not a Business Day, service shall be deemed to occur at 9am on the next following Business Day.

References to time in this clause are to local time in the country of the addressee.

- 6.3 A party may notify all other parties to this Agreement of a change to its name, relevant addressee, address or email address for the purposes of this clause 6, provided that, such notice shall only be effective on:
- (a) the date specified in the notification as the date on which the change is to take place; or
 - (b) if no date is specified or the date specified is less than five Business Days after the date on which notice is given, the date following five Business Days after notice of any change has been given.
- 6.4 In proving service, it shall be sufficient to prove that the envelope containing such notice was properly addressed and delivered to the address shown thereon or that the email was sent, as the case may be.
- 7. General**
- 7.1 This Agreement may be executed in any number of counterparts and by the parties to it on separate counterparts and each such counterpart shall constitute an original of this Agreement but all of which together constitute one and the same instrument. This Agreement shall not be effective until each party has executed at least one counterpart.
- 7.2 Except where this Agreement or any other agreement between the parties provides otherwise, each party shall pay its own fees, costs, expenses and taxes relating to the negotiation, preparation, execution and performance by it of this Agreement and of each document referred to in it.
- 7.3 The parties do not intend that any term of this Agreement shall be enforceable by virtue of the Contracts (Rights of Third Parties) Act 1999 by any person who is not a party to this Agreement.
