ASSIGNOR covenants that it will, upon ASSIGNEE's request, promptly provide ASSIGNEE with all pertinent facts and documents relating to said IP assets and legal equivalents in foreign countries as may be known and accessible to ASSIGNOR and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, assignments, instruments or affidavits required to apply for, obtain, maintain, issue, and enforce said IP assets and said equivalents thereof in any foreign country which may be necessary or desirable to carry out the purposes thereof.

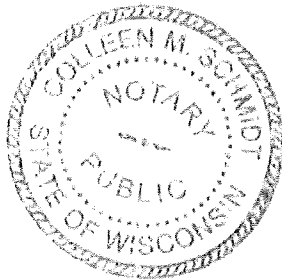

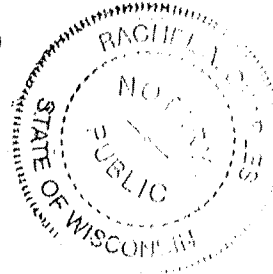
