**FIRST CERTIFICATE OF AMENDMENT OF
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
HEMAQUEST PHARMACEUTICALS, INC.**

HEMAQUEST PHARMACEUTICALS, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "**Corporation**"), does hereby certify:

FIRST: The name of the Corporation is **HEMAQUEST PHARMACEUTICALS, INC.**

SECOND: This corporation was originally incorporated pursuant to the General Corporation Law on July 26, 2007 under the name "HemaGenix, Inc."

THIRD: The Board of Directors of the Corporation, acting in accordance with the provisions of Sections 141 and 242 of the General Corporation Law of the State of Delaware, adopted resolutions amending its Amended and Restated Certificate of Incorporation as follows:

1. The name of the Corporation, shall, from and after the filing date hereof, be:

VIRACTA THERAPEUTICS, INC.

2. The second paragraph of Article Fourth shall be amended and restated to read in its entirety as follows:

"The total number of shares of all classes of stock which the Corporation shall have authority to issue is (i) 41,000,000 shares of Common Stock, \$0.0001 par value per share ("**Common Stock**"), and (ii) 30,500,100 shares of Preferred Stock, \$0.0001 par value per share ("**Preferred Stock**"). 100 shares of the authorized Preferred Stock of the Corporation are hereby designated "**Special Preferred Stock**," and 30,500,000 shares of the authorized Preferred Stock of the Corporation are hereby designated "**Series A-1 Preferred Stock**."

FOURTH: This Certificate of Amendment was submitted to the stockholders of the Corporation for their approval, and was duly adopted in accordance with the provisions of Sections 228 and 242 of the DGCL.

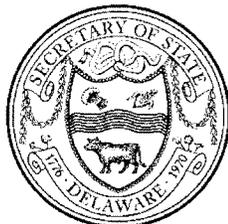

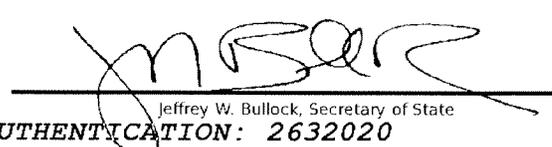
