ASSIGNMENT



Without additional compensation, but at the expense of Guardtime, upon the request of Guardtime and its successors, assigns and legal representatives, regarding the filing and prosecution of all applications for patents, enforcement of all patents, and maintenance of all rights in the Invention, patents, inventor's certificates and applications for patents or inventor's certificates based on the Invention, I agree to provide to Guardtime and its successors, assigns and legal representatives all information known to or ascertainable by me and all documents and other materials and objects pertaining to Guardtime's rights in the Invention that are in my possession or are accessible to me; and further, at any trial, hearing, deposition or other legal proceeding where I am called as a witness by Guardtime or its successors, assigns and legal representatives, I agree to testify to all facts pertaining to the Invention and Guardtime's rights in the Invention for which I am competent to testify;
5.
