**TERMINATION AND RELEASE OF SECOND LIEN SECURITY INTEREST IN
PATENT RIGHTS**

This TERMINATION AND RELEASE OF SECOND LIEN SECURITY INTEREST IN PATENT RIGHTS (this “Termination and Release”), is dated as of May 31, 2024, and made by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (together with its successors and assigns, the “Administrative Agent”) for the lenders party to the Credit Agreement referred to below in favor of THERABODY, INC. (formerly known as Theragun, Inc.), a Delaware corporation, and FLEXIR RECOVERY, LLC, a Delaware limited liability company (collectively, the “Grantors,” and each a “Grantor”).

WHEREAS, reference is made to (i) the Credit Agreement, dated as of August 12, 2021 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”) by and among the Grantors, the Administrative Agent, the other Loan Parties party thereto, and the Lenders party thereto, and (ii) the Pledge and Security Agreement, dated as of August 12, 2021 (as from time to time amended, restated, amended and restated, supplemented or otherwise modified, the “Security Agreement”) between the Loan Parties and the Administrative Agent;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered that certain Confirmatory Grant of Security Interests in Patents dated as of January 26, 2024 (the “Patent Security Agreement”) in favor of the Administrative Agent, for the benefit of the Secured Parties, which was recorded with the United States Patent and Trademark Office on February 1, 2024 at Reel 066435, Frame 0708;

WHEREAS, pursuant to the Patent Security Agreement, each Grantor, to secure the prompt and complete payment and performance of the Secured Obligations, pledged, assigned and granted to the Administrative Agent, on behalf of and for the ratable benefit of the Secured Parties, a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement), including, without limitation, the Patents and IP Licenses with respect to Patents to which such Grantor is a party referred to on Schedule A hereto; and

WHEREAS, the Grantors have requested and the Administrative Agent has agreed to terminate and release its Security Interest in the Patent Collateral (as defined in the Patent Security Agreement), including, without limitation, the Patents and IP Licenses with respect to Patents to which such Grantor is a party listed on Schedule A hereto, arising under the Patent Security Agreement and the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby states as follows:

1. **Definitions.** Capitalized terms used herein without definition are used as defined in the Patent Security Agreement or the Security Agreement, as applicable.

2. Release of Security Interest. The Administrative Agent, without recourse, representation or warranty, hereby terminates, releases, cancels and discharges its Security Interest in the Patent Collateral (as defined in the Patent Security Agreement), including, without limitation, the Patents and IP Licenses with respect to Patents to which such Grantor is a party listed on Schedule A hereto, arising under the Patent Security Agreement and the Security Agreement, and any right, title or interest of the Administrative Agent in the Patent Collateral arising under the Patent Security Agreement or the Security Agreement, as applicable, shall hereby cease and become void. If and to the extent that the Administrative Agent acquired any right, title or interest in the Patent Collateral (as defined in the Patent Security Agreement), including, without limitation, the Patents and IP Licenses with respect to Patents to which such Grantor is a party listed on Schedule A hereto, arising under the Patent Security Agreement or the Security Agreement, the Administrative Agent hereby re-assigns, re-transfers and re-conveys such right, title and interest to the applicable Grantor.

3. Termination. The Administrative Agent, without recourse, representation or warranty, hereby terminates and cancels the Patent Security Agreement.


4. Recordation. The Administrative Agent hereby authorizes and requests that the Commissioner for Patents of the United States Patent and Trademark Office record this Termination and Release.

5. Governing Law. THIS TERMINATION AND RELEASE SHALL BE SUBJECT TO THE PROVISIONS REGARDING CONSENT TO JURISDICTION, JURY TRIAL WAIVER AND THE OTHER MATTERS SET FORTH IN SECTIONS 7.17 AND 7.18 OF THE SECURITY AGREEMENT, AND SUCH PROVISIONS ARE INCORPORATED HEREIN BY THIS REFERENCE, MUTATIS MUTANDIS.
