TERMINATION AND RELEASE OF
SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

This TERMINATION AND RELEASE OF SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT ("Termination and Release"), dated as of June 20, 2024, is made by BARINGS FINANCE LLC, as the Collateral Agent for the Secured Parties ("Collateral Agent") in favor of TouchTunes Music Company, LLC, a Florida limited liability company (f/k/a TouchTunes Music Corporation, a Delaware corporation) (the "Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Security Agreement (as defined below) or the IP Security Agreement (as defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of April 1, 2022 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the "Security Agreement"), the Grantor executed a Second Lien Intellectual Property Security Agreement dated as of April 1, 2022 (the "IP Security Agreement") in favor of the Collateral Agent, which was recorded in the United States Patent and Trademark Office on April 5, 2022 at Reel 059619, Frame 0276 and at Reel 7681, Frame 0356, pursuant to which the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in the Collateral, including the patent registrations and patent applications listed on Schedule A hereto and made a part hereof and the trademark registrations and trademark applications listed on Schedule B hereto and made a part hereof.

WHEREAS, the Grantor has satisfied in full its obligations under Security Agreement and the IP Security Agreement and requests a release of the security interest in the Collateral granted thereunder; and

WHEREAS, the Collateral Agent now desires to terminate the IP Security Agreement and terminate and release its security interest in the Collateral, including the patent registrations and patent applications listed on Schedule A hereto and the trademark registrations and trademark applications listed on Schedule B hereto, and to reassign any and all rights, title, and interest in the same to the Grantor, as provided herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Collateral Agent, for itself and for the benefit of the Secured Parties, hereby irrevocably terminates the IP Security Agreement and irrevocably discharges, terminates and releases its Lien on and security interest in all of the Grantor's right, title and interest in and to the Collateral, including those patent registrations and patent applications set forth on Schedule A and those trademark registrations and trademark applications set forth on Schedule B.

2. The Collateral Agent hereby assigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Collateral Agent, any and all of the Collateral Agent's right, title, and interest in and to the Collateral, including those patent registrations and patent applications listed on Schedule A and the trademark registrations and trademark applications listed on Schedule B.

3. The Collateral Agent agrees to execute, acknowledge, procure and deliver all further documents and do all such other acts as may be reasonably required or desirable to carry out the purposes of this Termination and Release, including to effect the release of the Collateral Agent's security interest contemplated hereby.


4. The Collateral Agent authorizes and requests that the Commissioner of the United States Patent and Trademark Office and any other applicable government authority record this Termination and Release.

5. This Termination and Release and the rights and obligations of the parties hereto shall be governed by and construed and interpreted in accordance with the laws of the State of New York and shall be binding upon the parties' representatives, successors, assigns and transferees.
