TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS (this “Termination”) is dated as of June 20, 2024, and made by Wells Fargo Bank, N.A., as administrative agent and collateral agent (in such capacity, together with its successors and permitted assigns, “Administrative Agent”, and its capacity as Successor Agent (as defined below), collectively, the “Agent”) for the European Secured Parties and UK Secured Parties (as defined in the Credit Agreement referred to below).

WHEREAS, pursuant to (a) the Second Amended and Restated Senior Secured Global Revolving Credit Facilities Agreement, dated as of June 28, 2019 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), among International Automotive Components Group North America, Inc. (“US Borrower”), IACG Europe Limited (“European Borrower”), International Automotive Components Group Limited (“UK Borrower”), International Automotive Components Canada ULC (“Canadian Borrower”), the Lenders and the L/C Issuers from time to time party thereto and the Administrative Agent, and (b) that certain (i) that certain Patent Security Agreement (European and UK Borrower Obligations), dated as of July 24, 2018 (the “2018 Patent Security Agreement”), by the US Borrower in favor of the Administrative Agent for the benefit of the European Secured Parties and UK Secured Parties and (ii) Patent Security Agreement (European and UK Borrower Obligations), dated as of March 25, 2024 (the “2024 Patent Security Agreement”; together with the 2018 Patent Security Agreement, the “Wells Fargo Security Agreements”), by the US Borrower in favor of the Administrative Agent for the benefit of the European Secured Parties and UK Secured Parties, the US Borrower granted a security interest in favor of the Administrative Agent for the benefit of the European Secured Parties and UK Secured Parties in and to all of the US Borrower’s right, title and interest in and to the Intellectual Property (as defined below);

WHEREAS, (i) the 2018 Patent Security Agreement was recorded with the United States Patent and Trademark Office on July 31, 2018, at Reel 046673 and Frame 0807, and (ii) the 2024 Patent Security Agreement was recorded with the United States Patent and Trademark Office on April 10, 2024, at Reel 067054 and Frame 0565;

WHEREAS, pursuant to the Patent Security Agreement, dated as of September 30, 2015 (the “CF Lending Patent Security Agreement”; together with the Wells Fargo Security Agreements, the “Security Agreements”), the US Borrower granted to the CF Lending, LLC, as administrative agent under the Credit Agreement (as defined therein) for the benefit of the European Secured Parties and UK Secured Parties (each as defined in the Credit Agreement defined in the CF Lending Patent Security Agreement) a lien on and security interest in, all of its right, title and interest in, to and under the Intellectual Property;

WHEREAS, the CF Lending Patent Security Agreement was recorded with the United States Patent and Trademark Office on September 30, 2015, at Reel 036722 and Frame 0440;

WHEREAS, pursuant to the Resignation and Agency Substitution Agreement dated March 1, 2016 (the “Resignation Agreement”), CF Lending, LLC resigned in its respective capacity as administrative agent, and Wells Fargo Bank, National Association was appointed and accepted such

appointment, and agreed to act as the “Administrative Agent” under and as defined in the Credit Agreement (as defined in the CF Lending Patent Security Agreement) (in such capacity, the “Successor Agent”);

WHEREAS, pursuant to the Resignation Agreement, CF Lending, LLC assigned, and the Successor Agent was vested with and assumed, all the rights, powers, privileges and duties of CF Lending, LLC under the Credit Agreement (as defined in the CF Lending Patent Security Agreement), including its capacity as the administrative agent thereunder;

WHEREAS, the US Borrower has requested that the Agent release, and the Agent is willing to release its lien on and its security interest in, to and under the Intellectual Property and all related rights, title and interest of US Borrower in, to, and under the foregoing, including all reissues, reexaminations, continuations-in-part, divisionals, renewals and extensions of the foregoing, and all income, royalties, proceeds and liabilities at any time due or payable or asserted under any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (the “Released Patent Collateral”); and

WHEREAS, the Agent now desires to terminate and release the Wells Fargo Security Agreements and the CF Lending Patent Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. **Definitions**. Unless otherwise defined herein, the capitalized terms used herein which are defined in the Security Agreements shall have the meanings specified in the applicable Security Agreements. As used herein, the term “Intellectual Property” shall mean the Patent registrations and Patent applications constituting “Patent Collateral” as defined in the Wells Fargo Security Agreements or CF Lending Patent Security Agreement, as applicable, including those listed on Schedule 1 attached hereto.


2. **Release of Security Interest**. The Agent hereby terminates each Security Agreement and hereby absolutely and unconditionally terminates, releases, reconveys and forever discharges its security interest granted thereunder. The Agent further absolutely and unconditionally releases all of its right, title and interest in and to any and all property, assets and collateral secured, hypothecated or pledged under or by the Security Agreements, including the Intellectual Property.

3. **Further Assurances**. Upon request, at the sole expense of the US Borrower, the Agent shall deliver to US Borrower (or its designee(s)), and the US Borrower (or its designee(s)) is authorized to file, in accordance with applicable law, such terminations, filings, documents, agreements or instruments, as applicable (for the avoidance of doubt, in each case, to the extent delivered by the Agent), as may be necessary to enable US Borrower to terminate or release the Agent’s interest in the Intellectual Property in accordance with this Termination.

4. **Governing Law**. THIS TERMINATION SHALL BE GOVERNED BY AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE INTERNAL LAWS (AS OPPOSED TO CONFLICTS OF LAW PROVISIONS) OF THE STATE OF NEW YORK.

IN WITNESS WHEREOF, the Agent has caused this Termination to be executed by its duly authorized officer as of the date first written above.
