**ASSIGNMENT OF
INTELLECTUAL PROPERTY RIGHTS**

Recitals:

(A) The Assignor has rights in the Inventions described and claimed in British Patent Application No. 1504064.5 (the 'Patent Application') entitled 'Methods and Kits for Preparing Radionuclide Complexes'.

(B) The Assignor has agreed to assign to the Assignee for the consideration hereinafter mentioned all rights, title and interest in the Patent Application and the Inventions described therein (the "Intellectual Property"), including the right to file further applications to the Inventions, including International Patent Applications.

(C) The Intellectual Property represents a development of the Know-how licensed by the Assignor to the Assignee and attracts royalties on Licensed Products and Licensed Services, in accordance with the definitions and terms of a separate licence agreement ("the Licence Agreement") between the Parties.

1. Assignment:

1.1 In consideration for the payment of £1.00 by the Assignee to the Assignor the receipt and sufficiency of which are hereby acknowledged by the Assignor and the continued payment of royalties in accordance with the terms of the Licence Agreement as amended, the Assignor hereby assigns to the Assignee with full title guarantee all its rights, title and interest in the Intellectual Property.

1.2 The assignment effected by this clause 1 shall include, without limitation, the assignment and transfer of:

- (a) all patents and patent applications that may derive priority from the Intellectual Property or is in respect of the same Inventions in any country in the world; and
- (b) all rights of action, powers and benefits arising from ownership of the Intellectual Property, including the right to sue for damages and other legal and equitable remedies (and retain any financial award made in any action) in respect of all causes of action arising on or after the date of this deed.

2. Further Assistance

2.1 The Assignor shall at the expense of the Assignee execute any further documents that may reasonably be required by the Assignee to register the Assignee as proprietor of the Intellectual Property.

3. Identification of Intellectual Property

3.1 The Assignor hereby GRANTS the firm of C.P. Greaves & Co the power to insert in a Schedule to this Assignment any further identification of any patent applications in Canada or the United States or any other countries or regions of the world, as may be necessary or desirable in order to comply with the rules of the United States Patent Office or any other Patent Office for recordation of this document.

4. Governing Law and Jurisdiction

4.1 This agreement shall be governed by and interpreted in accordance with the laws of England, and the courts of England shall have exclusive jurisdiction to settle any disputes which may arise in connection with this agreement.
