Pursuant to Section 251 of the Delaware General Corporation Law (the “**DGCL**”), the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is Morphic Therapeutic, Inc., a Delaware corporation (“**Morphic**”), and the name of the Delaware corporation being merged into this surviving corporation is Lazuli, Inc. (“**Lazuli**”).

SECOND: An Agreement and Plan of Merger dated October 10, 2018 (the “**Agreement and Plan of Merger**”), setting forth the terms and conditions of the merger of Lazuli with and into Morphic (the “**Merger**”) has been approved, adopted, certified, executed and acknowledged by each of Morphic and Lazuli in accordance with § 251 of the DGCL.

THIRD: The Agreement and Plan of Merger is on file at Morphic’s place of business located at 35 Gatchouse Drive A2, Waltham, MA 02451.

FOURTH: A copy of the Agreement and Plan of Merger shall be furnished by Morphic, on request and without cost, to any stockholder of Morphic or of Lazuli.

FIFTH: The Certificate of Incorporation of the surviving corporation, Morphic, shall be its Certificate of Incorporation.

SIXTH: The Merger shall be effective as of the time that this Certificate of Merger is filed with the Secretary of State of the State of Delaware.
