## **RELEASE OF SECURITY INTEREST IN PATENTS**

**THIS RELEASE OF SECURITY INTEREST IN PATENTS** (this “Release”) is made as of June 28, 2024 (“Effective Date”) by **OAKTREE FUND ADMINISTRATION, LLC**, in its capacity as administrative agent for each member of the Lender Group (in such capacity, together with its successors and assigns in such capacity, “Agent”), in favor of **CREATIVE PLASTIC CONCEPTS, LLC**, an Ohio limited liability company (“Grantor”). Capitalized terms used but not defined herein have the meanings given to them (including by reference) in the Guaranty and Security Agreement (as defined below).

**WHEREAS**, pursuant to the terms and conditions of (a) that certain Guaranty and Security Agreement, dated as of May 13, 2022 by and between the Grantors, Agent and the other parties thereto (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “Guaranty and Security Agreement”), and (b) that certain PATENT SECURITY AGREEMENT by and between Grantor and Agent dated as of June 22, 2023 (the “Patent Security Agreement”), Grantor granted, assigned and pledged to Agent, for the benefit of the Lender Group, a continuing security interest in all of Grantor’s right, title and interest in and to the Patent Collateral (as defined in the Patent Security Agreement), including, without limitation, the patents and patent applications set forth on Schedule A attached hereto;

**WHEREAS**, the Patent Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on June 28, 2023, at Reel 064102, Frame 0757; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby (a) terminates the Patent Security Agreement and the Guaranty and Security Agreement, (b) terminates, cancels and releases the entirety of its security interest in the Patent Collateral, and (c) re-assigns and re-conveys to the Grantor any and all right, title or interest Agent may have in or to the Patent Collateral.

Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has in or against the Patent Collateral; and (iii) it has not recorded or otherwise evidenced its security interest with respect to any patent or patent application owned by Grantor, other than those of the foregoing patents and patent applications set forth on Schedule A (attached hereto), in any jurisdiction throughout the world.


