**TERMINATION AND RELEASE OF SECURITY
INTEREST IN PATENTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of June 28, 2024 (this “Release”), is made by **TWIN BROOK CAPITAL PARTNERS, LLC** (“Secured Party”), in favor of **RG DISPERSANTS USA LLC**, a Delaware limited liability company (“**RG Dispersants**”) (as successor in interest to GEO Specialty Chemicals, Inc.) (“Grantor”).

WHEREAS, pursuant to that certain Patent Security Agreement dated as of August 30, 2019, by Grantors in favor of Secured Party (the “Patent Security Agreement”), and that certain Amended and Restated Security Agreement, dated as of August 30, 2019 (as amended and restated pursuant to that certain Second Amended and Restated Security Agreement dated as of December 31, 2020), by and among the Grantors, Secured Party, and certain other parties (the “A&R Security Agreement”, and together with the Patent Security Agreement, the “Security Agreements”), the Grantor granted to Secured Party a continuing security interest in all right, title and interest of Grantor in, to all Grantors’ Collateral (as defined in the Patent Security Agreement), including the patents identified on the attached Schedule A (the “Patents”); and

WHEREAS, the security interest in respect of the Patents was recorded with the United States Patent and Trademark Office (“USPTO”) on August 30, 2019, at Reel 050219 Frame 0608.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the A&R Security Agreement or the Patent Security Agreement referenced in the preamble and recitals hereto, as applicable.

SECTION 2. Termination and Release. Secured Party, on behalf of itself and each of the Lenders, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:


- (a) terminates, cancels, discharges and releases the continuing security interest solely in, all of Grantor’s right, title, and interest in and to the Collateral, including the Patents and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the “Patent Collateral”), granted pursuant to the Security Agreements; and
- (b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
