- 1. The Transferor acknowledges, agrees and confirms that the Transferor assigned and transferred to the Purchaser all of its rights, title and interest whatsoever in and to patents and patent applications described in Appendix "A" attached hereto (the "**Patents**"), including for greater certainty any and all divisions, reissues, continuations and extensions thereof, and all rights of priority resulting from the filing of same. To the extent not thereby assigned or transferred, the Transferor hereby assigns and transfers all of its right, title and interest in and to the Patents to have and to hold all of the Transferor's right, title and interest in and to the Patents to the Purchaser, including but not limited to the right to invoke priority.
- 2. The Transferor authorizes and requests that any intellectual property office charged with administration of the Patents register and record this Confirmation, and register and record the transfer of ownership of the Patents from the Transferor to the Purchaser.
- 3. The Transferor and the Purchaser grant to the agent or attorney of record before the applicable intellectual property office for each of the Patents the power to insert on this Confirmation any further

identification that may be necessary or desirable for recording and registering this Confirmation with the applicable intellectual property office.

4. This Confirmation may be executed and delivered in multiple counterparts, including by means of facsimile machine or electronic mail in portable document format (.pdf), and each counterpart shall be deemed an original. All counterparts taken together shall be deemed to constitute the same instrument.
