CONFIRMATORY PATENT ASSIGNMENT

This Confirmatory Patent Assignment (“Assignment”) is made and entered into as of 02 March 2023 (the “Effective Date”), by and between Eppendorf SE, a European stock corporation (SE) registered with the commercial register of the local court of Hamburg, Germany and having its business address at Barkhausenweg 1, 22339 Hamburg, Germany (hereafter, “Eppendorf”), and Calibre Scientific GmbH, a limited liability company registered with the commercial register of the local court of Hamburg, Germany and having its business address at Landwehr 2, 22087 Hamburg, Germany (hereafter, “Calibre Scientific”). Eppendorf and Calibre Scientific may be referred to collectively herein as the “Parties.”

WHEREAS the Parties entered into an Agreement for the sale and purchase of assets of Eppendorf’s CellTech business dated 02 March 2023 (the “Asset Purchase Agreement”), whereby Eppendorf transferred, among other things, the Patent Rights listed in Schedule A to Calibre Scientific, and agreed – to the extent required under applicable laws - to execute and deliver separate confirmatory assignment documentation. This Assignment is intended for recording with the United States Patent and Trademark Office; and

WHEREAS the Parties wish to confirm the assignment of the Patent Rights listed in Schedule A.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Eppendorf hereby confirms that it has irrevocably sold, conveyed, transferred, assigned, and delivered unto said Calibre Scientific, and Calibre Scientific acquired, and accepted from Eppendorf, all of Eppendorf’s right, title, and interest in, to, and under the following (the “Assigned Patent Rights”):

1. the patents and patent applications set forth in Schedule A hereto and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals thereof (the “Patents”);
2. all rights of any kind whatsoever of Eppendorf accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;
3. any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

4. any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

Eppendorf further agrees to cooperate with Calibre Scientific hereunder in the sustaining of any and all the Patents, but at the expense of Calibre Scientific.

The U.S. Commissioner of Patents is hereby authorized and requested to record the assignment of such patents to Calibre Scientific in accordance with this Assignment

For said consideration, Eppendorf hereby agrees, upon the request and at the expense of Calibre Scientific, to execute any documents supporting any reissue, extension, re-examination, or renewal of any Letters Patent, and in the event of any Letters Patent assigned herein becoming involved in an interference or enforcement litigation, to cooperate to the best of the ability of the undersigned in the matters of preparing and executing the preliminary statement and giving and producing evidence in support thereof.

This Assignment shall be binding upon and shall inure to the benefit of the Parties hereto and their respective successors and assigns.

A signed copy of this Assignment delivered by facsimile, email, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

The Parties acknowledge and agree that this Assignment is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Eppendorf and Calibre Scientific with respect to the Assigned Patent Rights. The representations, warranties, covenants, agreements, and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.

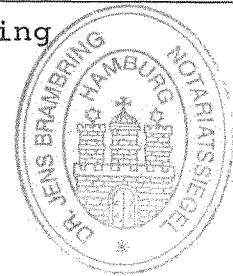


