THIS ASSIGNMENT OF PATENT RIGHTS (this "Assignment") is made and entered into effective this 1st day of January, 2024 (the "Effective Date"), by and between PEGASUS CONCEPT GROUP, INC. 2. All priority rights pertaining to said inventions and derived from any and all of said Patent Rights under any applicable convention;
3. The sole right to file applications for patents on said inventions under the patent laws of any country of the world in its name, and the sole right to have patents granted on said applications in its name, as fully and entirely as the same would have been held by Assignor had this assignment not been made; and
4. The sole right to enforce the Patent Rights with the right to sue and recover for Assignee's own use any accrued profits or damages for any and all infringements thereof, including, but not limited to, past infringements, with respect to which Assignor waives any right to receive any portion thereof.
