PATENT ASSIGNMENT AGREEMENT

This Patent Assignment Agreement (this “**Patent Assignment**”) is effective as of March 30, 2018 and is entered into between FlexHead Industries, Inc., a Massachusetts corporation (“**FlexHead**”), SprinkFLEX, LLC, a Massachusetts limited liability company (“**SprinkFLEX**” and, together with FlexHead, the “**Assignors**”), and Anvil International, LLC, a Delaware limited liability company (the “**Assignee**”). The Assignors and the Assignee are sometimes referred to herein as a “**Party**” and collectively as the “**Parties**.”

RECITALS

A. The Assignors are the owners of the patents and patent applications set forth on Schedule A hereto (the “**Patents**”);

B. The Assignors and the Assignee are Parties to that certain Asset Purchase Agreement, dated as of the date hereof (as may be amended from time to time, the “**Purchase Agreement**”), governing, among other things, the purchase and sale of the Purchased Assets and the assignment and assumption of the Assumed Liabilities. All capitalized terms used but not defined herein shall have the meaning attributed to them in the Purchase Agreement; and

C. Pursuant to the Purchase Agreement, on the terms and subject to the conditions thereof, among other things, the Assignors have agreed to sell, assign, hypothecate, transfer and convey to the Assignee all of each Assignor’s right, title and interest in, to and under the Patents, and the Assignee has agreed to purchase, acquire, accept and assume such Patents on the terms and conditions set forth in the Purchase Agreement.

AGREEMENTS

For the good and valuable consideration set forth in the Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged, the Assignors and the Assignee hereby agree as follows:

1. The Assignors do hereby irrevocably sell, assign, hypothecate, transfer and convey to the Assignee, its successors and permitted assigns, and the Assignee does hereby purchase, acquire and accept from each Assignor all of each Assignor’s right, title and interest in, to and under the Patents and any continuations, continuations-in-part, divisions, reissues, reexaminations, and extensions, and foreign patents and patent applications related thereto, and any rights to file applications and receive patents thereon, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, to the end of the term for which the Patents are or may be granted or reissued, as fully and entirely as the same would have been held and enjoyed by the Assignors if this assignment and sale had not been made; together with all claims for past and future damages by reason of infringement of the same, with the right to sue for past and future damages.

2. The Assignors hereby request the Commissioner for Patents at the U.S. Patent and Trademark Office (the “**Commissioner**”), as well as his or her counterparts at the corresponding entities or agencies in any country or jurisdiction that may exercise authority over any of the

Patents, to record this Patent Assignment. The Assignors hereby further request the Commissioner and his or her non-US counterparts to issue any and all patents resulting from applications among the Patents or derived therefrom to the Assignee as assignee of the entire interest therein.

3. This Patent Assignment is in all respects subject to the provisions of the Purchase Agreement and is not intended in any way to supersede, limit, qualify or expand any provision of the Purchase Agreement and is being executed and delivered pursuant to the Purchase Agreement. In the event of any conflict between this Patent Assignment and the Purchase Agreement, the Purchase Agreement shall control.

4. Each of the Parties shall, at any other Party's reasonable request, execute further papers (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation) and take such further actions as may be reasonably required to vest full title in and to the Patents in the Assignee or which may be necessary to obtain, renew, or issue the Patents, on the terms and subject to the conditions of the Purchase Agreement.

5. This Patent Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Patent Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Patent Assignment. The Parties to this Patent Assignment need not execute the same counterpart.

6. This Patent Assignment shall be governed by and construed in accordance with the internal laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of Laws of any jurisdiction other than those of the State of Delaware. The Parties irrevocably submit to the exclusive jurisdiction of the Federal District Court located in the District of Delaware or the Delaware Chancery Court in New Castle County, Delaware, for any Action arising out of or based upon this Patent Assignment, and hereby irrevocably and unconditionally waive any objection to the laying of venue of any Action in such courts and irrevocably waive and agree not to plead or claim in any such court that any such Action brought in any such court has been brought in an inconvenient forum.

7. This Patent Assignment may be amended, supplemented or otherwise modified only by a written instrument duly executed by the Parties. No waiver by any Party of any of the provisions hereof shall be effective unless explicitly set forth in writing and executed by the Party so waiving. The waiver by any Party of a breach of any provision of this Patent Assignment, whether intentional or not, shall not operate or be construed as a waiver of any subsequent breach. No delay or omission on the part of any Party in exercising any right, power, or remedy under this Patent Assignment shall operate as a waiver thereof.

8. This Patent Assignment shall be binding upon, and shall inure to the benefit of, the parties hereto and their respective successors and assigns. Neither Party may assign its rights or obligations hereunder without the prior written consent of the other Parties, which consent shall

not be unreasonably withheld or delayed. No assignment shall relieve the assigning Party of any of its obligations hereunder.

9. This Patent Assignment includes without limitation, the right to sue for past, present and future infringement of the interests assigned in this Patent Assignment and the right to collect and receive any damages, royalties, or settlement for such past, present and future infringements any and all causes of action relating thereto.

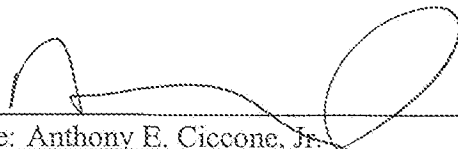
