INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT ("Assignment") is made as of this 26th day of June, 2024 (the "Effective Date"), by Cure Medical, LLC (also known as Cure Medical LLC), a California limited liability company having a place of business at 1434 E. Lake Mead Parkway, Suite 210, Henderson, NV 89015, USA and a postal address at 200 Crossings Blvd., Suite 101, Bridgewater, NJ 08807, USA (and previously of 3471 Via Lido, Suite 211, Newport Beach, CA 92663, USA; 3700 Newport Boulevard, No. 301, Newport Beach, CA 92663, USA; and 2113 Seville Avenue, Newport Beach, CA 92661, USA) ("Assignor"), and ConvaTec Inc, a Delaware corporation having its principal office at 200 Crossing Blvd., Ste. 101, Bridgewater, New Jersey 08807, USA ("Assignee").

WITNESSETH

WHEREAS, Assignor and Assignee are parties to an Asset Transfer and Assumption Agreement dated July 11, 2022 (the "Agreement"), pursuant to which Assignor has agreed to transfer to Assignee and Assignee has agreed to accept from Assignor certain assets, including, without limitation, certain intellectual property assets;

WHEREAS, Assignor has agreed to execute such instrument as Assignee may reasonably request in order to more effectively assign, transfer, grant, convey, assure and confirm to Assignee and its successors and assigns, all right, title and interest of Assignor in, to an under the intellectual property assets; and

WHEREAS, in accordance therewith, Assignor desires to and does hereby fully convey, transfer and assign to Assignee all of Assignor's worldwide right, title and interest in, to and under all of Assignor's intellectual property assets, including, without limitation, all of Assignor's common law and registered trademarks set forth on Exhibit A attached hereto, including any applications for each of the marks, together with the goodwill of the business associated therewith and which is symbolized thereby; provided that, with respect to the United States intent-to-use trademark applications set forth on Exhibit A, the transfer of such applications accompanies the transfer of that portion of the Assignor's business to which the trademarks pertain, and that business is ongoing and existing (collectively, the "Marks"); all of the assignors unregistered and registered designs set forth on Exhibit B, any copyright in the designs, in any associated preparatory materials, or in other works, including the right to apply for copyright registrations (collectively the "Designs") and the patents and patent applications set forth on Exhibit C and the inventions described therein, including any divisions, continuations, continuations-in-part thereof that have been or may be filed, any utility applications claiming priority thereto, any reissues, renewals or extensions thereof, any patent application which has been or may be filed on the invention in countries foreign to the United States of America and any patents granted thereon (collectively, the "Patents"). The Marks, Designs and Patents are hereby collectively referred to as the "*Intellectual Property Assets*."

NOW, THEREFORE, Assignor, for and in exchange for the consideration set forth in the Agreement, including one U.S. dollar (\$1 USD), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby assign, transfer, grant and convey to Assignee, free and clear of all pledges, security interests, liens, charges, encumbrances,

equities, claims, option or limitation of every kind, all of Assignor's worldwide right, title and interests in, to and under the Intellectual Property Assets, together with the goodwill of the business associated therewith and which is symbolized thereby (provided that, with respect to the United States intent-to-use trademark applications set forth on Exhibit A, the transfer of such applications accompanies the transfer of that portion of the Assignor's business to which the trademarks pertain, and that business is ongoing and existing), all rights to sue for infringement thereof, whether arising on, prior to or subsequent to the date of this Assignment and whether arising on, prior to or subsequent to the date of registration of this Assignment in the relevant patents register, any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States and in any other foreign jurisdiction and all priority rights in the United States and all foreign countries, the same to be held and enjoyed by Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Assignor had the Assignment not been made.

The Assignee agrees to the Assignment.

The parties hereto acknowledge and agree that the representations, warranties, covenants, indemnities, limitations and other terms contained in the Agreement shall not be superseded hereby but shall remain in full force and effect to the fullest extent provided therein. In the event of any conflict or inconsistency between the terms of the Agreement and the terms hereof, the terms of the Agreement shall govern.

Upon the reasonable written request by Assignee, the Assignor shall execute all documents and take all actions as may be necessary to enable Assignee to perfect, enforce, defend, register and/or record its right, title and interest in, to and under the Intellectual Property Assets, in each case, without further compensation from, but at the sole expense of, Assignee.

The Assignor hereby authorizes and requests the officials of the United States Copyright Office and the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign jurisdiction, to record and register Assignee as assignee and owner of the entire right, title and interest in, to and under the Intellectual Property Assets.

Assignor for itself, its successors and assigns, hereby covenants and agrees that, at any time and from time to time upon the written request of Assignee, Assignor will do, execute, acknowledge, and deliver or cause to be done, executed, acknowledged, and delivered, all such further acts, deeds, assignments, transfers, conveyances, powers of attorney, and assurances as may be reasonably required by Assignee in order to assign, transfer, set over, convey, assure, and confirm unto and vest in Assignee, its successors and assigns, title to the assets sold, conveyed, and transferred by this Assignment.

This Assignment is binding upon, and inures to the benefit of, the parties hereto and their respective legal representatives, successors and assigns. No waiver, modification or change of any provision of this Assignment shall be valid unless in writing and signed by the party against whom such claimed waiver, modification or change is sought to be enforced.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy

of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
