ASSIGNMENT OF TRANSFERRED ENCUMBERED INTELLECTUAL PROPERTY

THIS ASSIGNMENT OF TRANSFERRED INTELLECTUAL PROPERTY, dated as of January 2, 2024 (this "Assignment"), from Monroe Capital Management Advisors, LLC, a Delaware limited liability company (the "Lender Seller"), Arcstor Midco LLC, a Delaware limited liability company ("Midco"), Arcserve Acquisition Company LLC, a Delaware limited liability company ("Arcserve Acquisition"), Arcserve (USA) LLC ("Arcserve USA"), and, together with Midco and Arcserve Acquisition, the "Arcserve Assignors") and StorageCraft Technology, LLC ("StorageCraft Technology", and, together with Midco, Arcserve Acquisition and Arcserve (USA) LLC, the "Company Sellers") to Arcserve, LLC, a Delaware limited liability company (the "Purchaser").

WHEREAS, the Lender Seller, the Company Sellers and the Purchaser are parties to that certain Asset Disposition and Purchase Agreement, dated as of as of the date hereof (the "Purchase Agreement")¹;

WHEREAS, the Purchase Agreement contemplates that this Assignment will be executed and delivered by the Lender Seller concurrently with the execution and delivery of the Purchase Agreement;

WHEREAS, the Purchase Agreement provides for, among other things, for the sale by the Arcserve Assignors, at the direction and instruction of the Lender Seller, and the purchase by the Purchaser of all of the Arcserve Assignors' rights, title and interests in, to and under all intellectual property owned, licensed or sublicensed by or to the Arcserve Assignors, including, without limitation, those set forth in Exhibit A hereto and all of the Arcserve Assignors' rights to income on royalties attributable to the intellectual property, together with any and all goodwill of the Arcserve Assignors relating to the Business, (collectively, the "Transferred Encumbered Intellectual Property").

NOW, THEREFORE, in consideration of the covenants, representations and agreements set forth herein and in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. The Lender Seller (on behalf of and at the direction of the Required Lenders) hereby instructs and directs each of the Arcserve Assignors, and each of the Arcserve Assignors hereby assign and agree, to sell, assign, transfer, convey, and deliver exclusively unto the Purchaser all right, title and interest in and to the Transferred Encumbered Intellectual Property, including, without limitation, all intellectual property listed on Exhibit A hereto, and further including, without limitation:

(a) the goodwill of the Business symbolized by the names, marks, trade dress and other indicators of source included in the Transferred Encumbered Intellectual Property together with all registrations, applications for registrations, and common law rights in any country in the world;

(b) copyrights and any copyright registrations and applications included in the Transferred Encumbered Intellectual Property;

(c) issued patents and pending patent applications included in the Transferred Encumbered Intellectual Property;

(d) domain names included in the Transferred Encumbered Intellectual Property; and

(e) all rights to sue, recover and retain damages (and costs and attorneys' fees) for present and past infringement of any of the Transferred Encumbered Intellectual Property.

Except as expressly set forth in the Purchase Agreement, the foregoing conveyance is without any representation or warranty.

2. Further Assurances. The Lender Seller and the Arcserve Assignors hereby covenant and agree that, at any time and from time to time after the date of this Assignment, at the Purchaser's reasonable request, the Lender Seller and the Arcserve Assignors will do, execute, acknowledge and deliver, or will use all reasonable efforts to cause to be done, executed, acknowledged and delivered, any and all further acts, conveyances, transfers, assignments, and assurances as may become necessary to grant, sell, convey, assign, transfer, set over to or vest in the Purchaser any of the Transferred Encumbered Intellectual Property.

3. Acknowledgment of Rights. The Lender Seller and the Arcserve Assignors hereby acknowledge that, from and after the date of this Assignment, the Purchaser has acceded to all of the Arcserve Assignors' right, title and standing to:

(a) Receive all rights and benefits pertaining to the Transferred Encumbered Intellectual Property.

(b) Institute and prosecute all suits and proceedings and take all actions that the Purchaser, in its sole discretion, may deem necessary or proper to collect, assert, or enforce any claim of any kind relating to any right, title or interest assigned hereunder.

(c) Defend and compromise any and all such actions, suits or proceedings relating to any right, title or interest assigned hereunder, and perform all other such acts in relation thereto as the Purchaser, in its sole discretion, deems advisable.

(d) Register, maintain, renew or otherwise apply for new or continuing statutory protection for any Transferred Encumbered Intellectual Property, including but not limited to any patent, copyright and trademark protection.

4. No Third Party Beneficiaries. This Assignment shall be binding upon and inure solely to the benefit of the parties hereto and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer upon any other Person, any legal or equitable right, benefit or remedy of any nature whatsoever, including any rights of employment for any specified period, under or by reason of this Assignment.

5. Waiver. The Lender Seller waives and relinquishes any and all rights that it may have to any utilization of the Transferred Encumbered Intellectual Property or to object to any use of the Transferred Encumbered Intellectual Property by the Purchaser.

6. Severability. If any term or other provision of this Assignment is invalid, illegal or incapable of being enforced by any Law or public policy, all other terms and provisions of this Assignment shall nevertheless remain in full force and effect so long as the economic or legal substance of the transactions contemplated by this Assignment is not affected in any manner materially adverse to any party hereto. Upon such determination that any term or other provision is invalid, illegal or incapable of being enforced, the parties hereto shall negotiate in good faith to modify this Assignment so as to effect the original intent of the parties as closely as possible in an acceptable manner in order that the transactions contemplated by this Assignment are consummated as originally contemplated to the greatest extent possible.

7. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York without regard to conflicts of laws principles. All Proceedings arising out of or relating to this Assignment shall be heard and determined exclusively in any state or federal court of competent jurisdiction in New York County, Borough of Manhattan, State of New York. Consistent with the preceding sentence, the parties hereto hereby (a) submit to the exclusive jurisdiction of any federal or state court sitting in New York County, Borough of Manhattan, State of New York for the purpose of any Proceeding arising out of or relating to this Assignment brought by any party hereto and (b) irrevocably waive, and agree not to assert by way of motion, defense, or otherwise, in any such Proceeding, any claim that it is not subject personally to the jurisdiction of the above-named courts, that its property is exempt or immune from attachment or execution, that the Proceeding is brought in an inconvenient forum, that the venue of the Proceeding is improper, or that this Assignment or the transactions contemplated by this Assignment may not be enforced in or by any of the above-named courts.

8. Conflict. The parties hereto agree that in the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern and control.

9. Notices. All notices required to be given hereunder shall be provided in the manner set forth in the Purchase Agreement.

10. Counterparts. This Assignment may be executed and delivered (including by facsimile or electronic mail transmission) in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same Assignment. The terms of this Assignment shall not be construed against the drafter, as these drafting services have been performed as a courtesy to the other parties to this Assignment.
