BILL OF SALE

1. In full satisfaction of all amounts owed by Seller to Buyer pursuant to the Note, Seller hereby sells, transfers, assigns, conveys and delivers to Buyer all of its right, title and interest in and to the General Intangibles and expressly to the following property worldwide:


- A. All of Seller's patents, patent applications, and patent licenses to which it is a party (collectively, the "Patents"), including those referred to in Part A of Schedule I hereto;
- B. All of Seller's trademark registrations, trademark applications, and trademark licenses to which it is a party (collectively, the "Trademarks") including those referred to in Part B of Schedule I hereto, along with all goodwill associated therewith; and
- C. All proceeds and products of the Patents and the Trademarks, including without limitation, any claim or right to petition, sue, or otherwise seek and recover damages, profits and any other remedy (monetary, injunctive, declaratory, or other), for any past, present or future infringement, dilution, conversion or misappropriation of, or other injury, offense, violation, breach of duty or wrong relating to any of the foregoing, or any license, agreement, contract or matter relating thereto.

The internal laws of the Commonwealth of Virginia shall govern the validity and interpretation of this Bill of Sale and the performance by the parties hereto of their respective duties and obligations hereunder.


