**RELEASE OF SECURITY INTEREST IN PATENTS**

This RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”) is made as of July 16 2024, by CORTLAND CAPITAL MARKET SERVICES LLC, acting through one or more of its branches or any Affiliate thereof, as collateral agent (in such capacity, together with any successor collateral agent appointed pursuant to Article IX of the Credit Agreement, the “Collateral Agent”) for the Secured Parties in favor of AUTODATA SOLUTIONS, INC. and AUTODATA, INC. (each, a “Grantor” and, collectively, the “Grantors”). Capitalized terms used but not defined herein have the meanings given to them (including by reference) in the Security Agreement (as defined below).

WHEREAS, the Grantors are party to (i) that certain Second Lien Security Agreement, dated as of May 30, 2019, in favor of the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), and (ii) that certain Patent Security Agreement, dated as of May 30, 2019, in favor of the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Patent Security Agreement”), pursuant to which each Grantor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all of such Grantor’s right, title and interest in and to the Collateral (as defined in the Patent Security Agreement), including the Patents and Patent applications set forth in Schedule A hereto;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on May 31, 2019 at Reel/Frame 049336/0303 (Autodata Solutions, Inc.) and Reel/Frame 049336/0651 (Autodata, Inc.); and

WHEREAS, the Grantors have requested that the Collateral Agent execute and deliver this Release to evidence the release of its security interest in the Collateral for filing and recordation with the United States Patent and Trademark Office.


