THIS INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment") is made and entered into as of July 2, 2024 ("Effective Date") by and between:

FlexSteel Pipeline Technologies, LLC, a Delaware limited liability company (the "Assignee") having a principal place of business at 920 Memorial City Way, Suite 300, Houston, TX 77024 formerly having principal place of businesses at 910 Louisiana St., Suite 4400, Houston, TX 77002, 1201 Louisiana Street, Suite 2700, Houston, Texas 77002, 500 Dallas Street, Suite 500, Houston, Texas 77002, and 2103 Citywest Blvd., Suite 1450, Houston, Texas 77042.

WHEREAS, Assignor has agreed to acquisition by Assignee, and is desirous to sell all intellectual property assets to Assignee, including but not limited to those patents and patent applications listed in Exhibit A (the "Patents") and those trademarks and trademark applications listed in Exhibit B (the "Trademarks"); and

WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all of Assignor's rights in the Patents and Trademarks;

NOW, THEREFORE, in consideration of the covenants and agreements set forth herein, and other good and valuable consideration of \$1, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

#### ARTICLE I ASSIGNMENT

Section 1.1 Assignment. Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee all of Assignor's right, title, and interest throughout the world in and to the Patents and Trademarks, the underlying inventions claimed therein, including any provisional, non-provisional, continuation, continuation-in-part, divisional, reissue, reexamination, foreign, PCT or other patent application or like document, or any other application which claims priority to said application, in the United States and all foreign countries, together with the right of priority under any international agreements to which the United States adheres, and further, all rights and privileges pertaining to the Patents and Trademarks, together with all income, royalties, damages or payments due or payable as of the date hereof or thereafter related to any of the foregoing, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Patents and Trademarks, with the right to sue for and collect the same for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.

# ARTICLE II RECORDATION AND COOPERATION

- Section 2.1 <u>Recordation</u>. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and empowered officials of all other foreign jurisdictions to record the transfer of the Patents and Trademarks to Assignee, its successors, assigns and legal representatives. Assignee shall have the right to record this Assignment with all applicable government authorities and registrars so as to perfect its ownership of the Patents and Trademarks.
- Section 2.2 Further Assurances; Limited Power of Attorney. Assignor shall provide Assignee, its successors, assigns or other legal representatives, reasonable cooperation and assistance at Assignee's request and expense (including the execution and delivery of any and all affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documentation as may be reasonably required) as are requested by Assignee in connection with (i) perfection of the rights assigned herein, including the preparation, execution, and delivery of all documentation which may be reasonably necessary to further document and record the assignment of the Patents and Trademarks made herein, (ii) the preparation and prosecution of any application, continuations, divisionals, continuations-in-part, extensions or equivalent to any of the foregoing for any of the Patents and Trademarks; and (iii) the prosecution or defense of any interference, opposition, re-examination, inter partes review, post-grant review, or reissue proceeding that may arise in connection with any of the Patents and Trademarks, this Assignment or the assignment made hereby.

## ARTICLE III MISCELLANEOUS

- Section 3.1 <u>Entire Agreement</u>. This Assignment contains the entire agreement between the parties hereto with respect to the transactions contemplated hereunder, and supersedes all negotiations, representations, warranties, commitments, offers, contracts and writings prior to the date hereof, written or oral. No waiver and no modification or amendment of any provision of this Assignment shall be effective unless specifically made in writing and duly signed by the party to be bound thereby. Nothing in this Assignment is intended to confer upon any third party any rights or remedy of any nature whatsoever hereunder or by reason of this Assignment.
- Section 3.2 <u>Counterparts</u>. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which, together, shall constitute one and the same instrument.
- Section 3.3 <u>Assignment, Successors and Assigns</u>. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their permitted successors and assigns. For the avoidance of doubt, nothing in this Assignment will restrict in any way Assignee's ability to assign, license, transfer, pledge, or otherwise exploit any right, title, or interest in and to the Patents and Trademarks.
- Section 3.4 <u>Savings Clause</u>. Any term or provision of this Assignment which is invalid, illegal or unenforceable in any jurisdiction shall, as to that jurisdiction, be ineffective to the

extent of such invalidity, illegality or unenforceability without rendering invalid, illegal or unenforceable the remaining terms and provisions of this Assignment or affecting the validity or enforceability of any of the terms or provisions of this Assignment in any other jurisdiction. If any provision of this Assignment is so broad as to be unenforceable, the provision shall be interpreted to be only so broad as is enforceable.

Section 3.5 <u>Headings</u>. The captions of the various articles and sections of this Assignment have been inserted only for convenience of reference and shall not be deemed to modify, explain, enlarge or restrict any of the provisions of this Assignment.

Section 3.6 Governing Law; Jurisdiction and Venue. The validity, interpretation and effect of this Assignment shall be governed exclusively by the laws of the State of Texas without regard to any conflicts of laws principles. The parties irrevocably submit and consent to the exclusive jurisdiction and venue of the federal and state courts located in the State of Texas in any action brought to enforce, or otherwise relating to, this Assignment.


