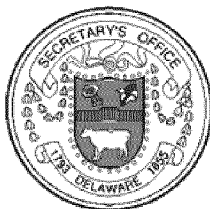

In accordance with the provisions of Sections 103 and 251 of the Delaware General Corporation Law (the “**DGCL**”), the undersigned corporation hereby certifies the following facts relating to the merger of MachEye Inc., with and into Verint Americas Inc. (the “**Merger**”).

1. The name and state of incorporation of each constituent corporation is MachEye Inc., a Delaware corporation (the “**MachEye**”), and Verint Americas Inc. (“**Verint**”), a Delaware corporation.
2. An Agreement and Plan of Merger, dated as of April 19, 2024, by and between MachEye and Verint (the “**Merger Agreement**”), has been approved, adopted, executed and acknowledged by each of the constituent corporations in accordance with Section 251 of the DGCL (and has been adopted by the stockholders of each constituent corporation acting by written consent in lieu of a meeting pursuant to and in accordance with Section 228 of the DGCL).
3. The name of the surviving corporation in the Merger is “Verint Americas Inc.”, a Delaware corporation.
4. The certificate of incorporation of Verint, as in effect immediately prior to the filing of this Certificate of Merger with the Secretary of State of the State of Delaware, shall be the certificate of incorporation of the surviving corporation.
5. An executed copy of the Merger Agreement is on file at 225 Broadhollow Road, Melville, NY 11747, which is the principal place of business of the surviving corporation.
6. A copy of the Merger Agreement will be furnished by the surviving corporation, on request and without cost, to any stockholder of the constituent corporations.
7. The Merger shall be effective at 12:01 A.M on April 19, 2024.
