**TERMINATION AND RELEASE OF
GRANT OF SECURITY INTEREST IN PATENTS**

This TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN PATENTS is made as of July 19, 2024 (this “*Termination and Release*”), by Ares Capital Corporation, as collateral agent (in such capacity, the “*Collateral Agent*”), for the benefit of Impact Products LLC, a Delaware limited liability company (the “*Grantor*”). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

A. Reference is made to (i) that certain Credit Agreement, dated as of June 30, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “*Credit Agreement*”), by and among, *inter alios*, SSE Intermediate, Inc., a Delaware corporation, as Holdings, SSE Buyer, Inc., a Delaware corporation, as the Borrower, the banks and other financial institutions or entities from time to time party thereto and the Collateral Agent, (ii) that certain Grant of Security Interest in Patents, dated as of June 30, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “*Patent Security Agreement*”), by the Grantor in favor of the Collateral Agent and (iii) that certain Guarantee and Collateral Agreement, dated as of June 30, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “*Security Agreement*”), by and among, *inter alios*, the Grantor in favor of the Collateral Agent.

B. Pursuant to the Credit Agreement and the Security Agreement, the Grantor executed the Patent Security Agreement, and, as security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations, granted the Collateral Agent a lien on and security interest in all of its right, title and interest in, to and under its registered Patents and Patent applications listed on Schedule I hereto, solely to the extent the same constitute Collateral of the Grantor (the “*Patent Collateral*”). The Patent Security Agreement was recorded with the U.S. Patent and Trademark Office on June 30, 2020 at Reel/Frame 53084/0224.

C. In connection with the release of certain security interests under the Loan Documents, the Grantor has informed the Collateral Agent of its desire to obtain the release of all right, title and interest of the Collateral Agent, in, to and under the Patent Collateral granted under the Patent Security Agreement.

Accordingly, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent does hereby terminate, release, cancel, relinquish and discharge any and all liens and security interests it has in, to and under the Patent Collateral, and reassigns, retransfers and reconveys all right, title and interest it has in, to and under the Patent Collateral to the Grantor. The Collateral Agent hereby authorizes the Grantor or any of its authorized representatives or designees to file this Termination and Release with the U.S. Patent and Trademark Office or any other applicable governmental office. At the request and sole expense of the Grantor, the Collateral Agent shall execute, acknowledge, procure and deliver to the Grantor such further documents and do such other acts as the Grantor shall reasonably request to evidence the release of the Collateral Agent’s lien on and security interest in, to and under the Patent Collateral. This Termination and Release and any further documents, and the performance of any actions by the Collateral Agent hereunder or thereunder, are made without representation or warranty by, or recourse to, the Collateral Agent.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY OR DISPUTE ARISING UNDER OR RELATED TO THIS TERMINATION AND RELEASE, WHETHER IN TORT, CONTRACT (AT LAW OR IN EQUITY) OR OTHERWISE, SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
