protection on applications as aforesaid, to issue the same to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

And the Assignor hereby represents that it has the full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith;

And the Assignor hereby agrees that it will communicate to Assignee, its successors, legal representative and assigns any facts known to the Assignor respecting said inventions, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and have or assist in having the inventors for said inventions do the same and generally use commercially reasonable efforts to aid the Assignee or its successors, legal representatives and assigns to obtain proper protection for said inventions in all countries.
