NOTICE OF RELEASE OF SECURITY INTEREST IN PATENTS

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN PATENTS, dated as of August 29, 2024, is made by REGIONS BANK, as administrative agent (the “Administrative Agent”), with offices at P.O. Box 12926, Birmingham, Alabama 35202, in favor of AXIENT LLC (f/k/a MILLENNIUM ENGINEERING AND INTEGRATION LLC), a Delaware limited liability company, having its chief executive office at 1400 Crystal Drive, Suite 800, Arlington, VA 22202 (the “Grantor”).

WITNESSETH:

WHEREAS, the parties entered into that certain Notice of Security Interest in Patent (the “Patent Security Agreement”), dated as of February 4, 2021, and which was entered into pursuant to that certain Amended and Restated Guaranty and Security Agreement (the “Security Agreement”) dated as of February 4, 2021, by and between the Administrative Agent and the Grantor, and which was duly recorded on February 4, 2021 at Reel 055152, Frame 0830 in the United States Patent and Trademark Office. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement.

NOW, THEREFORE, the parties hereby agree as follows:

1. Termination. The Administrative Agent, without representation or warranty of any kind, hereby (i) terminates and cancels the Patent Security Agreement; and (ii) terminates, discharges, cancels, and releases (and re-assigns all such right, title or interest to the Grantor), the license, security interest and any right, title or interest it may have in or to any of the Patent Collateral, including those patents set forth on Schedule 1 attached hereto.
2. Further Assurances. The Administrative Agent agrees to promptly execute and deliver any other release documents and to take all further actions reasonably necessary or appropriate as requested by the Grantor, at the Grantor’s sole cost and expense, to release the Administrative Agent’s Liens and security interests in the Patent Collateral.
