- (i) patents and patent applications listed on the attached **Schedule A** ("**Scheduled Patents**") together with any and all, existing now or in the future, continuations, divisionals, extensions, reissues, reexaminations, and registrations thereof, and all any foreign counterparts thereof;
- (ii) the right to file such applications and the right to claim for the same the priority rights derived from the foregoing patents and applications under the laws of the United States and all foreign countries, including the right to file foreign applications under the provisions of any convention or treaty;
- (iii) rights to causes of action (whether currently pending, filed, or otherwise) and enforcement rights under the foregoing including, without limitation, rights to sue, to countersue and to pursue damages, injunctive relief, and other remedies of any kind for past, current and future infringement; and
- (iv) rights to recover and collect settlement arrangements, license payments (including lump sum payments), royalties and other payments due now or hereafter due or payable with respect thereto, under or on account of any of the foregoing (collectively (i) thru (iv), "**Patent Rights**").

Assignor hereby authorizes the respective patent office or governmental agency in each jurisdiction in which any Patent Rights exist to issue any and all patents or other governmental grants or issuances as applicable that may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.

The terms and conditions of this Assignment of Patent Rights will inure to the benefit of Assignee, its successors, assigns, and other legal representatives and will be binding upon Assignor, its successors, assigns, and other legal representatives.
