PATENT RELEASE AND REASSIGNMENT (SECOND LIEN)

THIS PATENT RELEASE AND REASSIGNMENT (SECOND LIEN) is made as of July 23, 2024 (this “Second Lien Patent Release”), by UBS AG, STAMFORD BRANCH, in its capacity as collateral agent under the Intellectual Property Security Agreement referred to below (in such capacity, the “Agent”), in favor of PARAGON FILMS, INC. (“Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Intellectual Property Security Agreement (whether directly or by reference to another agreement or document).

W I T N E S S E T H:

WHEREAS, Grantor and the Agent were parties to that certain Intellectual Property Security Agreement, dated as of December 16, 2021 (the “Intellectual Property Security Agreement”), pursuant to which Grantor mortgaged, pledged and granted to the Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Patent Collateral (as defined below) as security for certain obligations owing by Grantor to Agent and the other Secured Parties;

WHEREAS, the Intellectual Property Security Agreement was recorded by the Assignment Recordation Branch of the United States Patent and Trademark Office on December 16, 2021 at Reel 058522, Frame 0633; and

WHEREAS, Grantor has requested that the Agent execute this Second Lien Patent Release to evidence the release of its security interest in the Patent Collateral and the reassignment of any and all rights the Agent may have in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Agent hereby releases, terminates and discharges its security interest in and to all of Grantor’s right, title and interest in, to and under the following Collateral (the “Patent Collateral”):

(a) all of its Patents, including, without limitation, those referred to on Schedule A hereto;

(b) all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing; and

(c) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. The Agent hereby reassigns and conveys to Grantor, without any representation, recourse or undertaking by the Agent, any and all of Agent’s right, title and interest in and to the Patent Collateral.

3. This Second Lien Patent Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.

4. Delivery of an executed counterpart of a signature page of this Second Lien Patent Release by telecopy, emailed pdf. or any other electronic means that reproduces an image of the actual executed


signature page shall be effective as delivery of a manually executed counterpart of this Second Lien Patent Release.
