## TERMINATION AND RELEASE OF PATENT SECURITY INTEREST

This **TERMINATION AND RELEASE OF PATENT SECURITY INTEREST**, dated as of August 30, 2024 (this “Release”), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Collateral Agent (as defined in the Patent Security Agreement referred to below) (in such capacity, “Agent”), in favor of SALLY HOLDINGS LLC, SALLY CAPITAL INC., SALLY BEAUTY SUPPLY LLC and LOXA BEAUTY SUPPLY (each, a “Grantor” and collectively, the “Grantors”).

**WHEREAS**, pursuant to that certain Patent Security Agreement, dated as of April 24, 2020 by and between Agent and the Grantors (as amended, restated, supplemented or otherwise modified from time to time, the “Patent Security Agreement”), the Grantors granted to Agent a security interest in all right, title and interest of Grantors in and to certain intellectual property;

**WHEREAS**, the Patent Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on April 24, 2020 at Reel 52490/Frame 0738.

**WHEREAS**, the Grantors have satisfied the terms of the Patent Security Agreement and request a specific release of the security interests granted and recorded against its intellectual property.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Patent Security Agreement.

**SECTION 2. Termination and Release.** Agent, without representation, warranty, or recourse, hereby:

(a) terminates the Patent Security Agreement and terminates, cancels, discharges, and releases all of its security interests in and to all right, title and interest of the Grantors in and to all intellectual property (including, but not limited to, all Patent Collateral under the Patent Security Agreement), whether granted pursuant to the Patent Security Agreement or otherwise (and including, but not limited to, the Patents listed on Schedule 1 attached hereto);

(b) reassigns, re-transfers and re-conveys to each Grantor all of its respective right, title and interest in and to all intellectual property (including, but not limited to, all Patent Collateral under the Patent Security Agreement) that the Agent may have, whether granted pursuant to the Patent Security Agreement or otherwise (including, but not limited to the Patents listed on Schedule 1 attached hereto), together with the goodwill of the business symbolized thereby;

(c) authorizes the Grantors or any of their authorized representatives or designees to file this Release with the USPTO or any similar office or agency within or outside the United States at the Grantors’ expense;

(d) further authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release; and

(e) agrees to execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by Grantors, at Grantors’ expense, to fully effectuate the purposes of this Release.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance

with the laws of the State of New York.


**SECTION 4. Miscellaneous.** This Release may be executed in any number of counterparts and by different parties on separate counterparts, each of which, when executed and delivered, shall be deemed to be an original, and all of which, when taken together, shall together constitute but one and the same Release. Delivery of an executed counterpart of this Release by telefacsimile or other electronic method of transmission shall be equally as effective as delivery of an original executed counterpart of this Release.
