2. Authorizes and requests the U.S. Patent and Trademark Office or any other U.S. or non-U.S. agency to issue any and all of the Patent Rights to Assignee.
3. Agrees to sign, and procure signature of, all papers and documents, including without limitation, applications, declarations, oaths, assignments and petitions, and, at Assignee's expense, perform any other acts necessary in Assignee's reasonable opinion in connection with prosecution, maintenance or enforcement of any of the Patent Rights.
4. Agrees that the terms, covenants, and conditions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representative, and shall be binding upon Assignor and its successors, legal representatives, and assigns.
